A regular county meeting was held on October 14, 2024, at 5:30 PM in the courtroom of the Towns County Courthouse.

Meeting Called to Order:

Commissioner Bradshaw called the meeting to order and welcomed all in attendance.

II: Presentation and Adoption of Agenda:

Commissioner Bradshaw presented the agenda, Andrea Anderson asked that it be amended to add the Emergency Meeting Minutes held on September 26, 2024 and to add the Towns County Sheriff's Office reallocations sheet to the budget amendment under new business. Commissioner Bradshaw accepted these changes, and it was adopted.

III: <u>Presentation and Approval of Minutes</u>

The Minutes from the Regular Meeting on September 17, 2024, a Called County Meeting on September 19,2024 and an Emergency Meeting on September 26,2024 were presented for approval and Commissioner Bradshaw approved and signed the same as presented.

IV: <u>Presentation/Reports/Proclamations</u>: Stuart Nichols, Rec Department Director gave an update on available programs. Tackle football had 146 children including cheer. Basketball is in signups now with 75 registered. Young Harris College has offered to do a free clinic for volleyball. There are golf and tennis clinics, adult basketball, yoga, aerobics and Ti Chi classes. We are compiling information for a Media Team for non-athletic children to write articles, do video and photography for the newspaper or Facebook. Foster Park entrance has new floors. We have worked 18 months on the Georgia DNR grant for a community pavilion and splash pad that has been approved. Donna Howell with the Retired Educators was presented a Proclamation making November 3, 2024, Retired Educators Day.

- V: <u>Old Business:</u> Approved Board of Education Homestead Exemption checks, none. Second Reading and Adoption of the Resolution to Amend the Code of Ordinances of Town County, GA, Chapter 40, Article VI, Section 40-169.
- VI: <u>New Business</u>: Signed the Resolution Accepting the Terms of the LWCF Project Grant. Signed the Department of Natural Resources Land and Water Conservation Fund Project Agreement. This grant is a 50/50%

match and we will use detainee labor as much as possible. We will add \$2,500 to the Food Bank. Signed the Budget Amendment Resolution, see attached Budget Amendment Table and TCSO re-allocation sheet.

Commissioner's Report: Early voting starts tomorrow through November 1st from 9:00AM - 5:00PM with two Saturdays on October 19th and 26th. The Fire Department has donated 200 Lb. of propane and two pallets of water to the Asheville area hit by Hurricane Helene. After receiving complaints at the last County Meeting, it has been decided that if a Tax Assessor meets with a member of the public, they will be required to have a witness in the room. The same will apply if someone comes to the Commissioners office to complain about a Tax Assessor employee, that employee will be called over to discuss the matter immediately while the complainant is present. The agenda is now being posted on-line and we are checking on how to broadcast our meetings on our website and the cost. We plan to have this available in January 2025. Commissioner Bradshaw asked Michael Anderson, Tax Commissioner, to explain that the Homestead Exemption credit issued by Governor Kemp was for one year only. Personal Property Tax is on the ballot to vote to change from \$7,500 to \$20,000.00. Rob Kiker, County Attorney presented further information on the tax assessment. The Board of Tax Assessors is an extension of the Commissioner from the State of Georgia Department of Revenue. They provide the rules, regulations and formulas on how real property is assessed. In 2012 we were below the ratio and were court ordered to bring the assessment up. Historically we have been at the bottom of the ratio at 36 percent. There are three board members on the Board of Equalization where you can appeal by providing private appraisal and comparable sales.

VIII: <u>Public Questions and Comments:</u> There were various questions and discussion on taxes, the Kubota train purchased from the Towns County Hotel/Motel Tax Fund and the rumor of a barking dog ordinance.
