### AWARD OF MERIT

At the discretion of the judge, will offer up to 10 Awards of Merit. All those in Best of Breed competition shall be eligible to receive an Award of Merit, except the Best of Breed Winner, the Best of Winners, and the Best of Opposite Sex Winner. Rosettes are offered for recipients of Awards of Merit.

#### \*\*\* Points For Reserve \*\*\*

At the National Specialty the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held. No major for Reserve Winners shall be given based upon an award of Best of Winners. In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld, shall not be included.

**PRIZES:** Trophies, Ribbons/Rosettes, or other prizes will be awarded in the ring to the person exhibiting the dog, who shall be considered the owner or agent. Please advise the Superintendent of any discrepancy at once. The Club reserves the right to substitute a prize of equal or greater value. No prizes will be mailed.

### **Best of Breed Competition**

### NON-REGULAR (ADDITIONAL) CLASSES INVOLVING SINGLE DOG ENTRIES For both Dogs and Bitches

Veterans 7 Yrs & under 9 Yrs Veterans 9 Yrs & under 10 Yrs 10 Yrs & under 11 Yrs 11 Yrs & older

Entrants in the Veterans Classes need NOT be intact. Spayed and neutered animals are eligible. Winners of the above Non-Regular Single Dog Classes, if otherwise undefeated are eligible to compete for Best of Breed.

#### NON-REGULAR (ADDITIONAL) CLASSES INVOLVING MULTIPLE DOG ENTRIES

\*As the judge's decision in the Stud Dog, Brood Bitch & Brace classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won either of these classes. Stud Dogs & Brood Bitches may be Spayed or Neutered.

**STUD DOG CLASS** – For Stud dogs & at least two of their Get. Stud dog must be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the stud dog need not necessarily be owner of the Get. While the merits of the Stud dog are not considered in the placement of the entry, the Stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under Dog Show Rules, AKC policy, or the standard of the breed. Get must be entered in a regular class, Best of Breed Competition, or some other Non-Regular classes. An entry fee of \$30.00 will be charged for the Stud dog if he is not entered in one of the Regular classes, Non-Regular classes or for Best of Breed Competition. Stud dog as an additional class is \$22.00.

**BROOD BITCH CLASS** - same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

**BRACE CLASS (NATIONAL SPECIALTY ONLY)**— The Brace Class shall be for two dogs of at least one identical owner or co-owner regardless of sex. The two dogs comprising the Brace shall be considered a unit and they must be named at time of entry. If a dog, which is to be part of a brace is not entered in a regular class, or Best of Breed Competition, the dog must be entered for "Brace Class Only". In making entries for Brace Class Only, full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as a part of a brace, MUST be marked accordingly in the space provided for ADDI-TIONAL CLASSES – "Brace Class." If more than one Brace is entered by the identical owner, the dogs comprising EACH brace must be designated, "Brace No. 1", "Brace No. 2", etc. Please submit Brace entries together. An entry fee of \$30.00 will be charged for the Brace as a UNIT if either dog is NOT entered in one of the Regular Classes, Non-Regular Classes or for Best of Breed Competition. Brace as an additional class is \$22.00 as a Unit.

\*\*Please note: When making entries online, please put the Name/AKC registration number of the other entrant comprising the Brace entry in the Comments Field. This must be done for every dog entered in Brace submitted online.

## JUNIOR SHOWMANSHIP

#### **Classes Divided by Age**

Novice Junior 9 & under 12 yrs Novice Intermediate 12 & under 15 yrs Novice Senior 15 & under 18 yrs Open Junior 9 & under 12 yrs Open Intermediate 12 & under 15 yrs Open Senior 15 & under 18 yrs

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show. Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have won three (3) first place awards, with competition present, in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Master Class - for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**NOTICE:** Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

Sweepstakes entries MUST be entered in a Regular class at the regular entry fee for the same show as the Sweepstakes. i.e. For the Regional Sweepstakes entry, the dog must be entered in a regular class for the Regional show. Indicate your Sweepstakes Class with age division in the space provided for "Additional Class". Sweepstakes entry fee is \$15.00

One combined class will be offered for American Staffordshire Terriers that are (4) four months & under (6) six months. There will be a selection of Best 4 & Under 6 Months Puppy and Best of Opposite Sex to Best 4 & Under 6 Months Puppy.

An AKC registration number or AKC litter number will be required for entries in this competition. A foreign born dog may enter this class if they are registered in the country of origin.

Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized. Professional handlers are not permitted to exhibit in this class.

AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise. Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this Best 4 & Under 6 Months Puppy in Show Competition.
