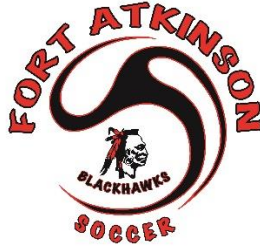
Coaches will be available for parents to answer questions about the season, cost and expectations.
