#### Job Summary

The Assistant Manager/Field Operations Manager reports to the Agency Manager and assists in the management, supervision and coordination of the activities and operations of the Agency. Job duties require roughly 50% field time and 50% office time. The position manages and participates in system repairs, emergencies, preventative maintenance scheduling and administers safety program. GWSSA operates an 2000 connection groundwater system, wastewater collection system, and a pressurized irrigation system including a 2600 AF reservoir. Requirements include a minimum of five years' progressive experience working in the water/wastewater field or closely related industry; or related technical education and demonstrated water/wastewater system experience and three years supervisory or management experience. Candidates must have experience with personnel administration, compliance, operations and new construction. Appropriate Utah State certifications required within one year of hire. Salary \$55,000 to \$75,000 DOE with a generous benefits package.

- Applicant must reside in or relocate to the Moab area.
- Applicant must obtain necessary certification within one year of hire. Water Distribution II, Sewer Collection II (higher grades preferred) and Traffic Control Supervisor
