Here are a few important notes about the show.

- Space sizes are 20' x 20'.
- You may request a particular aisle. However, a particular space or spaces may not be reserved. Spaces in the aisles are filled from back to front. Corner spaces are first come first serve. See reverse for Park layout.
- Set-up time is from 5:30 a.m. to 7:30 a.m. on show day. Reserved Corner Spaces can not be guaranteed after 7:30 a.m.
- Break down may not begin before 3:00 p.m. Your space must be empty by 5:00 p.m.
- Only one vehicle allowed in each space. All extra Dealer vehicles must be parked in specified area near Gate B.
- Breakfast and lunch will be available.

RULES OF NEW HARTFORD LIONS CLUB FLEA MARKET

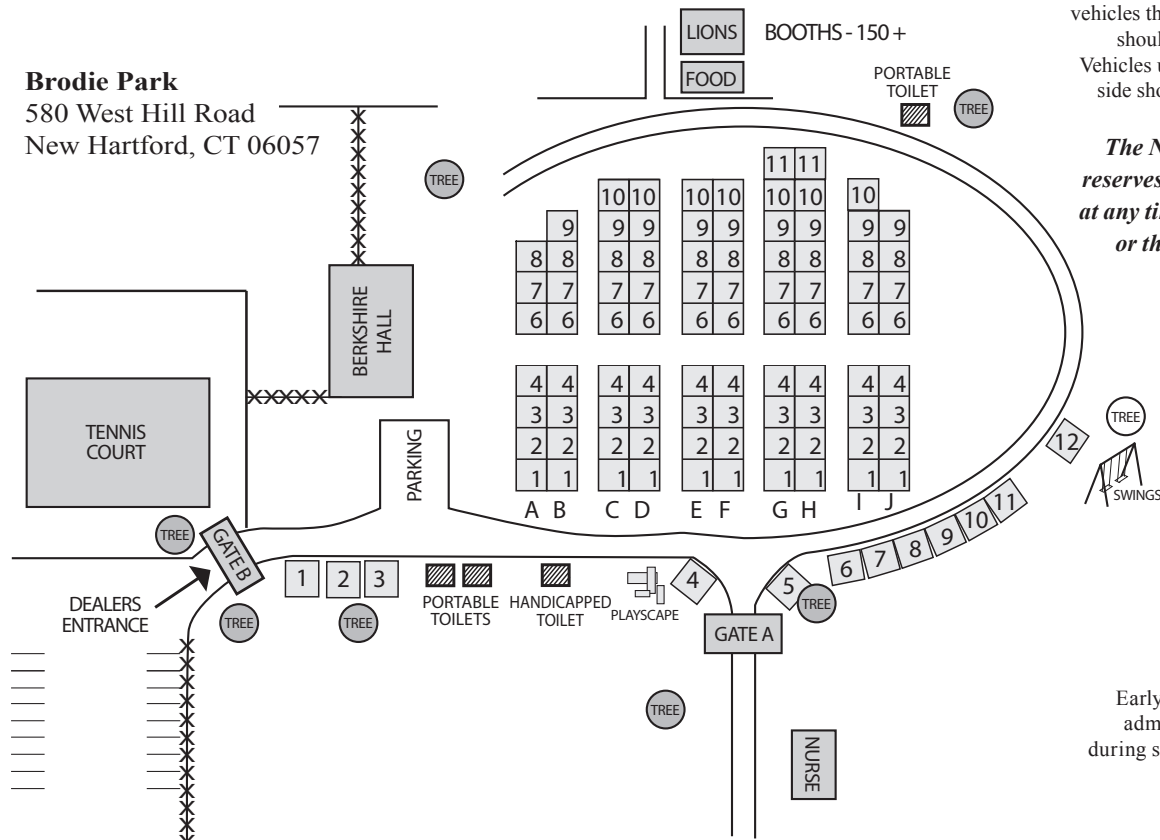
1. Because we are a service organization raising money for the community, the Town of New Hartford generously allows us the use of this location. We must leave it in the condition we find it. We would appreciate your help by taking your trash with you or use the dumpsters.
2. Dealers must be off the field by 5:00 p.m.
3. Space size is 20' x 20'. Please stay within your space or rent two spaces. Dealers in corner spaces must not place their merchandise into any aisle space that will impede auto or pedestrian traffic.
4. No food or beverages are to be sold or given away by dealers.
5. No pets are allowed on the grounds.
6. For any dealer who does not have a Connecticut State Tax Number, it is your responsibility to collect the Connecticut Sales Tax. All sellers should have a tax number and display the certificate so it is visible at all times. The State Tax Department allows two casual sales per year for which a tax number is not needed.
7. No auctioning, loud soliciting, or loud music is allowed at any time.
8. The New Hartford Lions Club reserves the right to have dealers remove objects it feels are inappropriate.
9. One vehicle per space/one dealer per space. Trailers may not protrude beyond the lines of your assigned space.
10. All extra dealer cars and trucks must be parked in the specified parking areas.
11. We do not reserve aisle spaces. We fill from back to front.
12. Only one vehicle per booth to unload at any given time.

IMPORTANT NOTICE:

Because of limited access in the aisles, all vehicles that unload from the Driver's side should select aisles - A,C,E,G,I. Vehicles unloading from the Passenger's side should select aisles - B,D,F,H,J.

The New Hartford Lions Club reserves the right to make changes at any time in the layout of the field or the position you selected.

Early buying customers will be admitted from 6:30-8:00 a.m. during set up for an extra fee of \$6.00

DIRECTIONS TO BRODIE PARK (SIGNS WILL BE POSTED AT ALL INTERSECTIONS) -- From the end of Route 8: Head East on Rt. 44, first right after Lombard Ford - West West Hill Rd., 3 miles on right. From Route 183 North: Right turn on to West Hill Road, 2 miles on left. From Route 219 West: Right turn on to West Hill Road, 3 miles. From Route 202: Turn onto Cedar Lane in Bakersville at traffic light. Follow signs 3 miles. From Route 44 West: Turn onto East West Hill Road across from the Antique Shop, or your next left onto West West Hill Road. At intersection with West Hill Road, turn right and immediately right again into Show entrance.
