# **Treasurer's Report**

Accounts Receivable. It was reported that the income for last month was standard revenue expected for this time of the year. It was reported that an Operating Line of Credit amount of \$75,000 was being processed and scheduled to be approved under Resolution 17-006 later in the meeting.

Accounts Payable. Chief Bennett noted that Rye Fire was required to pay an Ambulance License Fee this year for the ambulances, which is the first time we have been required to pay this. It is a part of Pueblo County requirements.

EMA Activity. Captain Beach reviewed the handouts.

Chief Bennett clarified how ambulance revenue information is processed. He noted that all EOB's and payments are received by Rye Fire. Colorado City Metro deposits any paper checks. Chief Bennett then scans the information, which is automatically faxed to EMA. In some cases, money is electronically deposited in our account and the EOB payment information is send via USPS mail to Rye Fire. Since Rye Fire processes the paperwork before sending to EMA, there is a short delay, typically at most a couple days, in getting information to EMA for their reports.

Mr. Rice, Chief Bennett, and Captain Beach will have a report for the Board next month for EMA Consultants. Chief Bennett will send out to the board a copy of our contract with EMA.

# **Fire Chief Report**

<u>Statistics.</u> In the Month November 2016, Rye Fire was busy responding to 85 calls for service of which 61 were EMS and 24 were fire related. In comparison with previous year this is an increase of 16% from 2015 and an increase of 19% from the 5-year average of 71.

<u>Administration/Operations.</u> A grant request has been submitted for the purchase of additional firefighter PPE and Life Pack 15 cardiac monitors.

As mentioned last month Rye Fire will be receiving 25 new handheld Motorola radios with batteries and chargers, dual head radios for the ambulances and new mobile radios for all vehicles, these radios are currently in the programming stage. These radios were purchased for Rye Fire through Pueblo County via funds from CSEPP and Homeland Security.

Currently in the process of evaluating and modifying the current burn permit regulations for the area within Rye Fire Protection District. A lot of the stipulations on our permit have been in excess of what other departments have. Further research will be looking at other areas with similar topography to see what other modifications can be made. The no burning in our District is still in effect. There will be a few days when light snow is on the ground that will allow people to burn small piles if the weather is adequate.

Participated with Pueblo Parade of Lights, fire truck was decorated with a lot of lights and Rudolph. The personnel and truck are initially used for traffic control and then they follow the end of the parade.

<u>Prevention.</u> We continue to provide Mitigation assessments for homeowners throughout the District. A lot of the mitigation assessments are requested from the homeowner's insurance or the insurance agent of the purchaser.

Rye Fire assisted with their monthly fire drills.

<u>Training.</u> Training has been ongoing. Fire training covered ladder operation, fire behavior, mapping and SOG's. EMS training is ongoing with a new topic every 6 days providing continuing education for annual requirements.
