VISION STATEMENT:

To sustain the health and vitality of God's kingdom workers in the North Wisconsin District through prevention, intervention and remedial care.

OVERALL STRUCTURE:

It is the goal of the North Wisconsin District to offer help in the following ways to sustain healthy kingdom workers—

- 1. Preventive Care—Educational and wellness services.
- 2. Interventive Care—To assess and refer troubled workers who are facing professional or personal issues that impact their work performance as kingdom servants.
- 3. Remedial Care—Counseling and treatment of those workers (and families). This may occur through the District Counselor, or through referral to an outside counselor/facility.

DISTRICT COUNSELOR:

Pastor Dan Kohn is a full-time pastor serving Bethlehem Lutheran 'Church in Altoona, Wisconsin. Before becoming a pastor, Dan was a licensed mental health and addictions counselor for over 30 years. He is the author of four books, one of which is *The Resilient Pastor*. He is also a synodically-trainer reconciler. Dan has been married for 40 years, has two adult children, and three grandchildren.

ROLE OF THE DISTRICT COUNSELOR:

Pastor Kohn will assist the District in the following ways:

- Researching and disseminating resource information to pastors and congregations in the areas of wellness and counseling care.
- 2. Providing direct counseling and referral services for troubled workers (and their families).

- Creating written resources and training events to assist workers sustain health and proactively address work-related and personal issues.
- 4. Being the primary point of contact with issues related to counseling questions and concerns; and assistance with referrals to outside counselors, or other resources.
- 5. Being a liaison between the District and outside service providers in the coordination and facilitation of services.

CONFIDENTIALITY:

Contacts with Pastor Kohn related to counseling care will be kept confidential. The limited exceptions to this will be the following:

- 1. In those areas where synod has a "zero tolerance" policy (i.e. sexual misconduct).
- 2. Where there is State "mandatory reporting" requirement (i.e. child or elder abuse & neglect, etc.)
- 3. Where there is a risk of physical harm to self, or others.

CHRISTIAN COUNSELING BACKGROUND INFORMATION

The following facilities identify themselves as "Christian" or "biblical" in their counseling. Such facilities are rare, as most counseling is done from a secular perspective, where the Bible is not a reference in the counseling that is done. It is encouraged that you make personal contact with the facility you choose to learn more details in regard to the specific areas their counselor(s) are trained to address. Each counselor has strengths and limitations. The majority of centers are licensed to provide mental health counseling. Addiction counseling is less available. Those counselors who accept insurance payment for counseling have to be licensed in mental health and/or addictions in order to legitimately counsel in those areas, and to receive reimbursement for the counseling they do.

Most counseling centers have a webpage. This is a good place to start in your investigation of an individual center, or counselor.

It is also important to check to see if a particular facility and therapist is covered under Concordia Health Plan, or other insurance coverage you may be under. Under Concordia Health, six sessions are covered for church workers, or family members.

There may be other individual counselors or agencies that would also come under the above headings of "Christian" or "biblical" that are not listed here. As mentioned earlier, the vast majority of counseling clinics are secular, and do not use the Bible as a text for the work they do with clients. This reinforces the reason for the development of this resource directory, which is meant to be a guide to you, as a beginning of the process to access quality Christian care giving.

Pastor Dan Kohn is also available for counseling. He is the assigned District Counselor. He has 30+ years of previous experience as a licensed mental health and addictions counselor. It is the goal of the District Office to assist called and commissioned workers in gaining the help they may need to remain productive, faithful servants of Christ.

ADVICE FROM A SEASONED COUNSELOR...

One of the most frequent challenges I have seen pastor encounter is their response to the plea—"Help!"

There is a natural tendency...and an expectation to immediately get involved. Let me suggest the "twp-steps-back" approach to such a request—

- 1. First "back step"—Answering the question—Am I trained to respond as a professional caregiver for this person?
- 2. Second "back step"—If the answer to # 1 is "No," then what boundaries will I be crossing if I say "Yes?"

As a part of a valuable "reality check" in regard to offering counseling, keep in mind that a professional counselor is required to have a Masters Degree in Counseling, or related field, and 3000 hours of clinical experience before being qualified, by state standards, to counsel. Interpretation: One or two seminary classes on pastoral care does not qualify any pastor to counsel (which involves-assessment, diagnosis and treatment of complex human problems).

A boundary that is crossed when an under-trained pastor agrees to counsel someone is one found in professional ethics—Offering services when unqualified to do so. Said differently, this implies that a pastor is presenting himself as fully qualified to do what is not reasonably feasible, tied to lack of training and experience.

Boundary two that is being crossed is to not refer the potential client to someone who has the credentials to be an effective caregiver. One of the first consideration for an untrained pastor, upon getting a request for help, is to go into "referral mode." This implies that the pastor is familiar with counseling resources at his disposal. Personal visits with outside counselors can be very beneficial.

With all this said, it needs to be emphasized that a pastor appreciate his skills and abilities when it comes to spiritual guidance. Most pastors are better trained at the application of Scripture than the average, outside counselor. What can be very beneficial to the person in therapy is to also be guided by the pastor in deeper spiritual matters. This can also be reviewed when a pastor meets with an outside counselor.

When a client in counseling is willing, it is valuable for him/her to sign a "Release of Confidential Information" form to allow for an exchange of communication between the trained counselor and pastor. Now a pastor is in his element and a more confident, trained caregiver to his parishioner.
