Nominations & Elections Information 2018 June - July 2018

Election and Term of Office - The election of the Directors shall be finalized at the annual meeting of the Members. Members may provide a written vote (by US mail or e-mail) for such election, as long as such written vote is received by the Corporation **ten (10) days before the annual meeting - July 31, 2018**. If such written vote is not sent via certified mail, the Corporation shall not be responsible for the receipt of the vote.

Nominations are open for the following 6 NASS BoD Positions in 2018:

1. **NW Regional Director - Term July 31, 2018 - July 31, 2021 (3 Year Term)**
2. **MW Regional Director - Term July 31, 2018 - July 31, 2021 (3 Year Term)**
3. **SW Regional Director - Term July 31, 2018 - July 31, 2021 (3 Year Term)**
4. **Board of Director at Large – Term July 31, 2018 – July 31, 2020 (2 Year Term)**
5. **Board of Director at Large – Term July 31, 2018 - July 31, 2020 (2 Year Term)**
6. **Board of Director at Large - Term July 31, 2018 - July 31, 2020 (2 Year Term)**

Nominations will be taken until **Midnight June 14, 2018**. Nominees must accept the nomination and provide their Bio by the nominations deadline date.
