STEP 6

"Were entirely ready to have God remove all these defects of character"

THE ONE THING I NEED TO KNOW ABOUT STEP 6

Willingness is the Key

Principle of this Step: Willingness

STEP SUMMARY

All 12 steps are important- but Six and Seven ARE the meat and substance of our program! We must have an extremely healthy and personal relationship with them, or else we are likely to drink again!"

We were so ill-prepared and highly untrained to not only see but understand how our pride, anger, greed, gluttony, lust, envy, and sloth (our P.A.G.G.L.E.S), all founded in fear (fear of not getting something we demand or of losing something we possess), were the components that kept leading us to the only solution that seemingly worked every time- alcohol.

The purpose of Step 6 is to become fully prepared to rid ourselves of the flaws we listed in Step 4, to become willing to let our Higher Power remove our defects and to stop pursuing what our idea of perfection is. The sixth step is a call to perfection. It separates those who are working the program and those who drift through the program. "The difference between 'the boys and the men' is the difference between striving for a self-determined objective and for the perfect objective which is of God.".

MYTHS ABOUT THIS STEP

One of the biggest misconceptions about this Step is that we have the ability to become less of these things on our own. We do not have the skill set to become less of the flaws in our character that have caused our failure. It is way above our pay grade. We strengthen our faith in a Power greater than ourselves and allow God to remove them from us.

INVENTORY/ WITH GOD AND IN AA

Inventory:

Taking a step displays a willingness to write inventory and allow it to surrender something within us. Write inventory on your most serious shortcomings around the practical application of this step in your life today ("How am I applying the spiritual principle found in this Step to every moment of my life?")

With God and in A.A.:

- -Do I use justified resentments as an excuse to criticize others and enjoy self-righteous anger?
- -Do I wish for what I do not have rather than working for it?
- -Am I entirely ready to have God remove all my defects of character?

"The only problem we ever really have is separation from God"

TRADITION 6

Short Form: "An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose"

Long-form: "Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to AA should be separately incorporated and managed, thus dividing the material from the spiritual. An AA group, as such, should never go into business. Secondary aids to AA, such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the AA name. Their management should be the sole responsibility of those people who financially support them. For clubs, AA managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside AA- and medically supervised. While an AA group may cooperate with anyone, such cooperation ought never to go as far as affiliation or endorsement, actual or implied. An AA group can bind itself to no one."

STEP-TRADITION PARALLEL

The sixth step poses the question, how can I become entirely ready to have my defects of character removed? The answer is in the sixth tradition. In fact the sixth tradition describes main character defects: the problems involved from seeking money, property, and prestige. The sixth tradition contains the solution to my problems of money, property, and prestige: the more primary in my life carrying the message becomes, the less problems of any kind I have!

Therefore, observing the sixth tradition in my life by placing my primary purpose of carrying the message first, and not my problems of my property, prestige, or worthy outside of interests, keeps me sober.

CONCEPT 6

Short Form: "The conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board."

Long Form: "On behalf of AA as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting the large matters of general policy and finance. But the conference also recognizes that the chief initiative and active responsibility in most of these matters should be exercised primarily by the trustee members of the conference when they act among themselves as the General Service Board of Alcoholics Anonymous.
