Board of Public Affairs -

Ms. Pat Cochenour updated council on the process of the new well. She also noted that the board has agreed to raise the minimum service charges by \$1.00 for consumers within the village limits and \$1.50 for those outside the village limits. Usage rates will remain the same.

Ms. Maxwell reported on the proceedings of the recent meeting of the IJFD.

Park Board -

It was determined that the parts needed to repair the large piece of playground equipment are covered under warranty, however the village will need to pay the shipping charges which will cost around \$539.00. The board will also be getting a quote to find out what the costs would be to have the same company install the replacement parts.

Finance Committee –

Ms. Maxwell relayed information from previous council meetings in which the finance committee suggested and council agreed to support a \$30,000 transfer to a new storm water fund that would be paid back over a three year period.

Police Report -

Chief Freyhof reported that two of the three cruisers have been serviced for the winter. The tires are in need of replacement. He will checking to see if there is money left in the budget to replace them yet this year.

Council agreed that the letter should identify that "council" is objecting to the approval rather than the "village". Mayor Reames will make the changes and present the revised draft at the next meeting for council's approval and signatures.
