

RESOLUTION NO. 2021-2
RESOLUTION OF THE BOARD OF COMMISSIONERS OF
BAYOU D'ARBONNE LAKE WATERSHED DISTRICT
RELATING TO BOAT LAUNCH FEES

WHEREAS, pursuant to Ordinance No. 2021-1, the Board of Commissioners (the "Board") of the Bayou D'Arbonne Lake Watershed District (the "District") adopts the regulations set forth herein relating to boat launch fees at boat launches owned by the District on D'Arbonne Lake (the "Lake"):

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF THE BAYOU D'ARBONNE LAKE WATERSHED DISTRICT:

A. Launch Fees.

1. Application.

- 1.1 A boat launch fee (sometimes "Launch Fee") will apply to all persons launching a boat or other watercraft at a launch ramp owned by the Commission on the Lake.
- 1.2 Persons launching a boat shall pay the daily launch fee at the ramp or obtain and display a valid annual launch permit.

2. Daily Launch Fee.

- 2.1 The Daily Launch Fee is \$5.00.
- 2.2 The Daily Launch Fee is to be paid in cash or by check and inserted in the envelope provided and placed in payment box located at each ramp at the time of launch.

3. Annual Launch Permit.

- 3.1 An Annual Launch Permit is \$50.00 for each year for the period beginning July 1 and ending June 30.
- 3.2 An Annual Launch Permit for (i) senior citizens (65 years and older) and (ii) military veterans is \$25.00 for each year for the period beginning July 1 and ending June 30.
- 3.3 Annual Launch Permits may be purchased from area vendors.
- 3.4 Owners of property on or near the Lake which pay an electric or gas franchise fee may obtain an Annual Launch Permit at no cost at the Union Parish Chamber of Commerce Office in Farmerville.

B. Collection Procedure.

- 1.1 A written policy shall be adopted by the Board related to the collection of the daily Launch Fees and the proceeds from the Annual Permit sales.

C. Effective Date.

- 1.1 The Launch Fees referred to herein shall become effective on September 1, 2021.

BE IT FURTHER RESOLVED, that the District authorizes the presiding President or Vice-President of the District to execute any and all documents necessary to effect the implementation of the boat launch fees and related matters.

Said Resolution having been read and considered by a quorum of the Board of Commissioners, on motion to adopt by Commissioner Terry Morris, seconded by Commissioner Richard Royal, a record vote was taken, and the following result had:
