**A RESOLUTION OF THE BOROUGH OF LIBERTY, COUNTY OF ALLEGHENY,  
AND COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING FEES FOR THE  
FILING OF APPLICATIONS, PERMITS, AND LICENSES.**

WHEREAS, Borough Council of the Borough of Liberty has adopted a codification, consolidation, and revision of the ordinances of the Borough of Liberty; and

WHEREAS, it is the desire of Borough Council of the Borough of Liberty, to eliminate all filing fees, permit fees, and license fees from the Code of Ordinances and enact them instead by resolution; and

NOW, THEREFORE BE IT RESOLVED THAT and it is hereby resolved by Borough Council of the Borough of Liberty, that all fees are hereby fixed as follows:

**LICENSES, PERMITS, AND GENERAL BUSINESS**

- 1 Mechanical Amusement Devices
  - a. Amusement Device §13-206
    - i. Annual License Fee \$500
- 2 Solicitation/Transient Retail Merchants
  - a. License required §13-302
  - b. License Fee
    - i. Per Day, Per Person \$20
    - ii. Per Week, Per Person \$100
    - iii. Per Month, Per Person \$250

**PARKS AND RECREATION**

- 1 Pavilion/park permits
  - \$25 resident \*
  - \$50 non-resident \*
- \*All fees are non-refundable
- 2 Field Permits \$350

**SEWERS AND SEWAGE DISPOSAL**

- 1 Dye Test Certificate of Compliance §18-409
  - a. At least 21 days prior to the sale of property, the seller (hereinafter, "applicant") shall apply to the Borough for a certificate of compliance \$50
  - b. If a certificate of compliance for the property has been issued within the 5 years preceding the date of the application, the Ordinance Compliance Officer may waive the dye testing requirement if the Ordinance Compliance Officer inspects the property and finds no evidence of illegal connections. In this event, the Ordinance Compliance Officer may issue a certificate of Compliance upon payment of a fee to the Borough. \$35

  - a. cash security \$3,000

1 Posting of Signs

- a. license fee §19-105
  - i. to defray the costs of administration \$10
  - ii. deposit \$50

**SOLID WASTE**

1 Solid Waste Regulations

- a. Borough License §20-106
  - i. daily license \$5 per day
  - ii. monthly license \$10 per month
  - iii. annual license \$100 per year

**STREETS AND SIDEWALKS**

1 Street Openings

- a. Permits required §21-201
  - i. Street/alley
    - 1. first 25 square feet \$125
    - 2. 26-50 square feet \$2/square foot
    - 3. square feet thereafter \$1/square foot
  - ii. sidewalk \$200 per opening
- b. Bond required \$3,000
  - i. Written application shall be made for the opening up of any such street, alley, or sidewalk, upon proper forms provided by the Borough Secretary, and no permit shall be issued unless the applicant shall first furnish unto the Borough of Liberty a surety bond, cash, or certified check

  - a. Preparation fee \$25 per parcel
- 2 Municipal Lien Letter \$20 per parcel



**SECTION 2. REPEALER:** All prior Fee schedules and resolutions are hereby repealed in whole or in part to the extent inconsistent herewith.


**SECTION 3. EFFECTIVE DATE:** This Resolution shall take effect immediately and in accordance with applicable law.
