### ENGINE 11 IS IN-SERVICE

After almost a year of planning, design and construction ENGINE 11 is in-service and providing fire protection for this community. This is a front line Pierce Velocity Pumper, carrying 1,000 gallons of water, foam and a full complement of tools and equipment for protection and preservation of our homes and businesses. There is over 2,700 feet of various sized hose, a dozen nozzles, over 100 hand tools, fans, self-contained breathing apparatus, thermal imagers, gas monitors and other equipment needed to operate under many different conditions.

### HOW WE HAVE CHANGED

Over the years the roles of the Fire Company have changed to include a major component; Emergency Medical Services (EMS). Last year we responded to over 2,400 calls of which 1,224 were for Advance Life Support. With advancements in medical care, pre-hospital treatment can greatly improve the outcome of an emergency medical response. Most of these advancements are driven by training, technology and field drug administration. These interventions to treat the patient at the scene come at a cost to the community. The support provided by individuals and business help cover the cost of these necessary items on the scene and throughout the journey to a hospital and in to the care of physicians.



A recent testament to the effectiveness of a community supported system is the purchase of three new heart monitor/defibrillator units offering advanced support in treating cardiac patients and aiding with advanced therapeutic care.

Donations from the community and a grant from the Virginia Department of Health's Virginia Rescue Squad Assistance fund made this possible.

## AT THE READY!

One of our goals is to maintain two front-line all-weather Advance Life Support (ALS) Transport Units available for Emergency Medical Service calls to serve the 23,000+ residents in the 50 square miles we provide service to. To do this we have again applied for a grant from the Virginia Rescue Squad Assistance Fund to help with the replacement of a 16 year old ambulance. This grant could help cover 50% of the purchase price, still leaving well over \$100,000.00 of funds we must raise to make the purchase. Also, this grant does not cover equipping, maintaining, insuring and fueling the unit.

**All Open Burning Prohibited**

The Virginia Department of Environmental Quality (DEQ) mandates and enforces the Western Virginia Emissions Control Area which includes Frederick County. Open burning is prohibited countywide during the period of May 1st through September 30th of each year (§9VAC5-20-206). ## ANCILLARY BUILDING

### COMING SOON

The current arrangement of apparatus and equipment storage has become limited due to the growth of department needs and service provided. An ancillary building has been in the planning stages for almost a year.

Over the past 78 years the land and building has grown from a 2,000 sq. ft. building on a quarter acre to a 10,000 sq. ft. facility consisting of storage, living quarters, training area, meeting space, storage and a 3,000 sq. ft. community hall all residing on 4 acres of land in the Town of Stephens City.

The ancillary building will add an addition 4250 sq. ft. of storage to the facility and be used to store a Technical Rescue Squad, Reserve Fire Engine, three rescue boats, a haz-mat support trailer, grounds maintenance equipment, and other support items related to emergency response.



We are diligently working with the Town of Stephens City and the County of Frederick to construct this much needed facility to serve this area for years to come.
