# **VACATION DO'S & DON'TS**

It's Summer time! Time to head to the pool, BBQ, and go on vacation! In order to have peace of mind during your vacation, before you hit the road, take a few precautions so your home isn't enticing to thieves or susceptible to fire and other disasters.

Here are some tips to keep your home and property safe while you enjoy some much needed time away:

- Call on friends for help. If you're going to be away a week or more, ask a trusted friend to check on your house every day or two—or better yet, housesit—while you're gone. Not only will they make sure nothing happens to your home, but you might also ask them to bring in your mail and newspapers, water plants or even feed Fluffy. Of course, it's a good idea to let your neighbors know a friend is monitoring your property so they don't call the police to thwart a perceived "break-in."
- Set your lights on a timer. Leaving your house unlit for days on end is a sure sign to burglars that it's empty, but so is keeping the lights on 24-7. A good way to handle the lights on/off conundrum is to set them on a timer that's scheduled to simulate your regular routine. However, if the lights seem a bit too simulated, that can be another telltale sign, so it's a good idea to set the timers in individual rooms on staggered schedules to make the light coming from your home seem more natural.
- Stop your mail and newspaper. Nothing screams "nobody's home!" like a pile of newspapers strewn about your doorstep or an overflowing mailbox. So, if you can't get a friend or neighbor to collect them for you, it's best to have your mail and paper stopped if you're going to be out of town for awhile.
- In a world where it seems everyone is blabbing about their business on social networking sites like Facebook and Twitter, it's important to stop and think: Who exactly is reading this stuff? The anonymity of the Internet can encourage us to share personal information without fully realizing that there may be hundreds of complete strangers receiving our daily musings. Would you announce to a crowd that you will be leaving your house unattended for two weeks this December? If not, then you should think twice about posting your detailed vacation plans on Twitter or Facebook -- especially if that information is visible to Internet users other than your friends and family (and it probably is).
- Be careful what you say on your answering machine or voice mail too. Callers don't need to know that you're not home -- they just need to know that you can't come to the phone right now.
- Don't leave the spare house key lying around. That fake rock where you keep the extra house key
  isn't as discrete as you think. Whether you keep a spare under your welcome mat, above the door
  frame or in a hide-a-key contraption, chances are it will take the burglars five minutes flat to find
  it and gain easy entry to your house. So take it with you, let a friend hold onto it, or put it in a
  safe place inside your house.
- Make a last-minute checklist. Are all the windows and doors locked? Stove and oven turned off? How about all the faucets? Are the electronics unplugged and valuables secured? Take five minutes before you leave to ensure your house is vacation-ready. Another run-through of the house may seem unnecessary if you did it earlier in the day, but knowing you've left your house as safe as possible will help you kick back and have a great vacation.

### **SNAKE SAFETY & AWARENESS**

The photo below shows a Copperhead snake recently seen on the walking path through the woods in our neighborhood. The Northern Copperhead is the only venomous snake species commonly found in Fairfax County. Copperheads may be found basking in the sun, on trails and in rocky areas, or in stream valleys. They are most active between April and October.

Copperheads can be identified by their triangular head shape, vertical pupil and hourglass scale pattern that runs the length of their body. They may be copper-colored or light brown and tan color.

Most snake bites occur when snakes are handled or accidently touched by someone walking or climbing. The venom of a small or young snake is more potent than that of a larger adult.

Safety tips to Reduce Chances of a Snake Bite

- Figure 1 If you see a snake, stop and keep a safe distance. Give the snake room to move away on its own.
- ➤ Do not try to handle any snake. Any snake will bite if provoked.
- When walking or hiking, stay on trails, sidewalks and cleared pathways
- ➤ Wear boots or closed shoes and long pants when working outdoors or walking in wooded areas
- ➤ Wear leather gloves when handling brush and debris
- ➤ Use a flashlight if walking at night in areas where snakes might be present
- ➤ Keep dogs on leashes and pet cats indoors to reduce chances of them encountering a snake.

If you find a sick or injured snake, contact the police non-emergency line at (703) 691-2131 to be connected with Animal Control. If you are bitten by a snake you believe could be venomous, seek emergency medical attention immediately.

## **POOL NEWS**

#### **Hiddenbrook Pool Guest Pass Policy**

No member family shall have more than four (4) guests (or one guest family) at one time.

Birthday parties or other such gatherings are permitted. The member family may have a maximum of 20 guests and there must be one (1) adult present for every five (5) children. Up to three picnic tables can be reserved. It is very important that the event is scheduled at least 48 hours in advance with the lifeguards. The lifeguards have the right to limit the number of parties at the pool for safety and occupancy reasons. If you are planning a party, it's best to contact them well in advance to ensure your spot on the calendar. Persons not in swimwear will be allowed to enter the pool without paying a guest fee. #### We Need Your Help!

During the first two months of our pool season we often experience an overload of trash when we host the home swim meets here at Hiddenbrook. We have added extra trash receptacles but there is still an issue with putting the trash in the proper receptacles. We ask that you help us deal with this situation by doing the following:

- ➤ When you are finished with your meals, snacks or treats, please deposit all remaining disposable items in the proper trash receptacles
- > Separate all recyclables and put them in the receptacles marked for that purpose Note: pizza boxes and any materials with food residue on them are not recyclable
- > Break down any large boxes or items that will take up a lot of extra space in the receptacles
- Keep restrooms clean by putting all trash in receptacles provided
- ➤ We purchased a diaper pail for diapers only and it is located in the changing space in the ladies restroom. Please do not put diapers in any other receptacle
- > Please notify one of the lifeguards if you notice a full trash receptacle that needs to be emptied
- > Do not put loose trash in any receptacle that does not have a liner in it

## **Yard Signs**

We recently had a visit from Fairfax County personnel who were removing illegal signage from residential yards. Examples of items being removed were advertisements for yard sales and missing pets taped to street signs and light poles.

At least two of the yellow "SLOW DOWN" signs that were placed in the grass strip on the street side of the sidewalk were removed. These signs are permissible but only for short periods of time. They should be placed in homeowners' yards only and removed frequently then set out again in another area in order to have the intended effect on speeding drivers.

We ask that residents be courteous and remember to remove temporary signage in a timely manner. For any long-term signs, please do not place them on county property or in areas that may block a driver's line of sight. (i.e., corners / curves)
