I bring to this office 12 years of experience in policy, governance, and my strong interagency relationships. My accomplishments include increasing funding for school supplies; securing emergency funding to pay for trauma counseling for elementary students; increasing the number of crossing guards; working to pass bond Measures A & B, which fund much needed facilities improvements to all of our schools; and serving as an effective board president and delegate to the California School Boards Association statewide assembly. remain committed to addressing our district's achievement gap; to stewarding the many bond-funded facilities projects our district is currently undertaking; and to ensuring that our students are academically challenged and supported. If re-elected, I will continue to dedicate my time, energy, and passion to the success and safety of our students. As I mentioned in the last question, I have been lobbying CSBA to create a Director at Large, LGBTIQ; I recently collaborated on creating a presentation titled "Supporting Students who Identify as LGBTQ+: Student and Expert Perspectives" that will be at the CSBA annual conference this coming December; I participate in Santa Cruz Pride every year as an elected to publicly show my support for the LGBTIQ community, I am a standing member of the Alliance and the Human Rights Campaign

The Stonewall Riots in 1969; Harvey Milk, first openly county board supe; Clinton's "don't ask, don't tell" policy re: military service; the long road to marriage equality, John Laird elected first openly gay mayor in the US - these are the first few that come to mind.

I remain open to working with all people across our community. As an elected, it is my responsibility to give voice to those who do not always have the social capacity to advocate for themselves, and to listen to those who represent the underrepresented. This philosophy informs all that I do as a trustee.
