1. Déjà vu, Antique Mall, its agents, officers, or employees shall not be liable for property damage or personal injury to Exhibitor, its agents or employees, which may occur on or about any part of the subject premises, regardless of how much injury or damage may have occurred. Exhibitor waives any claim against Déjà vu Antique Mall and assumes all liability for loss or damage to Exhibitor property entrusted to the premises, including outside show areas. Exhibitor shall hold Old Town Market harmless and shall indemnify Déjà vu Antique Mall against all liability or expenses arising out of any claim of injury or damage to any person or property, together with all costs in connection with the defense thereto, including attorney's fees.

2. Set-Up: Set-up of booths must be complete at show opening and must remain set-up and *open for business until show closing*. Booths and aisles must be kept clear for safe access throughout show hours. Dealers who rent outside booth spaces are responsible for their own white tents/awnings and the safe keeping of their property.

4. Déjà vu Antique Mall reserve the right to make rules and regulations it deems proper and necessary, and Exhibitor agrees to accept such rules and regulations and any interpretation as is set forth by Déjà vu Antique Mall.

5. All municipal, state and federal requirements in connection with sales must be fulfilled, including licenses and permits, sales tax, electrical, fire department regulations and no smoking ordinances. (See floor plan) NO PETS ALLOWED IN THE BUILDING.

6. This contract cannot be assigned without the prior written consent of Old Town Market. No booths may be shared without the prior written consent of Déjà vu Antique Mall.

7. The use of help, to assist unloading and loading, is at Exhibitors own risk, and Déjà vu Antique Mall shall not be liable for any resulting injury or claim.

8. Full payment of rental fee is due with application.

9. Cancellation: Space Rental Fees will not be returned if Exhibitor cancels within 60 days of show. Half of the space rental fee will be returned if Exhibitor cancels 61 days or more before show. No-Show: Any Exhibitor who fails to show up for any show for which he or she has contracted will forfeit space rental fee. Should any show be cancelled by Old Town Market, for any reason, this contract is null and void, and Exhibitor waives any all claims, except space rental fee return. Rain does NOT cancel the show.
