## President's Message

When I joined the Board three years ago, I had two projects in mind that would be a benefit to all the members at Fiesta Gardens Homes Association. The first was to update the old Governing Documents from the 1950's to reflect updated Civil Codes that now govern homeowner's associations as well as to clarify some of the old language. The second was get a new clubhouse built.

Governing Documents: In late September 2016, the Association membership received and were asked to vote on the revised Governing Documents for Fiesta Gardens Homes Association. In January 2017, the Association counted those ballots. While the revised by-laws passed at that time with over 50% of the eligible membership voting in favor, the CC&R's did not since they required a super majority or 75% of the eligible members to vote in favor. This was the third attempt at getting these documents passed and it was very clear that due to apathy and other issues we would never get a super majority to even vote. The only other option was to petition the court to reduce the requirement to 50%. We are happy to announce that San Mateo County Superior Court granted the Association's petition and the amended CC&R's are now adopted by Fiesta Gardens Homes Association and have been filed with the county.

A big THANK YOU to everyone, you know who you are, who helped over the past few years in getting this done. It was a team effort.

Now onto the new clubhouse!!!

## Civic Report

Traffic Action Plan (TAP)

Update from the City: The signs have been installed on westbound 19th at Ginnever restricting left-turns for vehicles over 5 tons. The original signs we placed needed to be replaced with the weight restriction signage in order for it to be enforceable. Our PD has already begun enforcement of these new signs.

We've also begun the sight distance evaluation for the intersections on Bermuda. The evaluation for Texas and Bermuda has been completed. Once approved, the adjacent property owners will be notified of the new red curb installation. After their notification, the curbs will be painted. This is the process we'll use for all intersections. We should be able to do the sight distance evaluations for the rest of the Bermuda intersections next week, and get the notifications out shortly after that.

#### Residential Permit Parking Program (RPPP).

There has been general agreement of the need for permitted parking in the north area of Fiesta Gardens. Please see the link below regarding the City's Residential Permit Parking Program (RPPP). These are the guidelines the City and residents follow when applying for parking permits on their street.

## FGHA BOARD MEETING - June 7, 2017

Approved Minutes, Respectfully Submitted, Karen Debono, Secretary

The Board Meeting, which was held at Fiesta Gardens Pool Cabana, was called to order at 7:08pm. Board Members in attendance were: Joe D'Agostino - President, Roland Bardony - Parks, Carmen Quaresma - Social Director, Steve Muller - Vice President, Steve Stanovcak - Pool Operations, and Rich Neve - Civic. Mike Russell - Pool Maintenance, was absent.

May Minutes: On a motion duly made and seconded and approved by all board members present, the minutes of the May 3, 2017 meeting were approved.

#### Financial - Christina Forrest

- Reported that she will be moving FGHA insurance to another broker and obtaining more comprehensive coverage.
- o Reported that the court case information for the CC&R hearing was mailed to FGHA homeowners.
- o The Board agreed to pay the pest control bill in advance to receive a discount.

#### President - Joe D'Agostino

- o Governing Documents there will be a court hearing held on July 18, 2017 to obtain approval to lower the percentage of votes needed to pass the new CC&Rs.
- o The city requires a soil test before the Planning Department will approve the building plans for the new club-house. They require this to be done before September, or there will be additional charges. Two proposals have been received from Soils Engineers. One for \$15,000 and one for \$7,000. The Board made a motion to select the proposal for \$7,000, it was seconded and approved by all board members in attendance.
- o The city will require solar for the new clubhouse. The plan can be submitted to the Planning Department and then installed at a later date.
- o Once the permit has been obtained, it will be good for one year.

#### Open Forum:

- o A resident stated that the small pool was shut down last year several times due to children having potty accidents in the pool.
- Residents in attendance discussed possible solutions to prevent potty accidents in the pool, such as: having swim pullups available for sale, posting signs reminding parents to put swim pullups on their children and putting an article in the BEE.
- o A resident asked what the total amount was outstanding on assessments and when was the Board going to attempt to collect it.

Vice President - Steve Muller: no report submitted

#### Civic - Rich Neve:

- o Reported that kids using Fiesta Meadows Park for soccer games have been getting into FGHA Children's Park. They may be responsible for breaking the lock on the gate. He would like to contact whoever is responsible for setting up the soccer games to inform them that only FGHA residents and guests are allowed inside the park.
- o Reported the City's Traffic Action Plan possible steps for FGHA neighborhood.
- o The County Fair opens this Saturday.
- o There will be a City-Wide Garage Sale on Saturday, July 17th 8am 2pm. You can go to the city's website for more details and to sign up.
- o Sewage Tank there is a contract to rent the Event Center for the sewage tank, but he has not heard a status update as of tonight's, board meeting

#### Social - Carmen Quaresma:

o Summer Pool Party: Has been scheduled for Saturday, July 8, 2017. A Taco Truck will be parked in front of the pool on Bermuda Drive for attendees to purchase food items. The Pool Party will have games and activities for all to enjoy. There will be a parade prior to the Pool Opening at Fiesta Meadows Park beginning at 11am.

#### Parks - Roland Bardony:

- o Reported that the day-cares currently using Fiesta Gardens HOA's parks have their own insurance coverage.
- o Reported that the lock on the Children's Park gate had been broken.

Pool Maintenance- Mike Russell: absent - no report.

Pool Operations - Steve Stanovcak:

o Reported that a new pool pump has been installed. The wait to receive the new pump took longer than anticipated and delayed the opening of the pool by one weekend.

- Reported that he would be distributing the new pool bands by the upcoming weekend. He reported that he
  had been provided, by Christina Forrest, a list of owners that are not up to date on their assessment payments.
- o Steve Stanovcak thanked Ernie for cleaning up the pool area in preparation of the pool opening.
- o Swim Lessons will be held Mondays Thursdays with the exception of the first week of June.
- o Steve Stanovcak answered a question from a resident during Open Forum regarding the Board collecting past due assessments. He reported that the first step was obtaining the approval of the new CC&Rs from the judge on July 18th. He reported that there is approximately \$116,000 in outstanding assessment dues.

It was noted that the next Meeting will be held on Wednesday, July 5, 2017 at 7:00pm. There being no further business before the Board, the Meeting was adjourned at 7:53pm.
