NEW COLLECTION AGENCY

2018 TAX INFORMATION

Borough tax bills have been mailed out, so please remember these items when paying your bill:

- Tax collector office hours are Wednesdays from 12:00-4:00 p.m.
- If you need a tax receipt, you will need to pay in person to the tax collector or include a self-addressed STAMPED envelope with payment
- If you call for information or payment arrangements, please provide your name, contact information, and the property address on the bill
- Borough Secretary does NOT have access to tax information and can only accept payments by check, money order or exact amount (office does not have change)

Summary of Clean Water Act

33 U.S.C. §1251 et seq. (1972)

The Clean Water Act (CWA) establishes the basic structure for regulating discharges of pollutants into the waters of the United States and regulating quality standards for surface waters. The basis of the CWA was enacted in 1948 and was called the Federal Water Pollution Control Act, but the Act was significantly reorganized and expanded in 1972. "Clean Water Act" became the Act's common name with amendments in 1972.

Under the CWA, EPA has implemented pollution control programs such as setting wastewater standards for industry. We have also set water quality standards for all contaminants in surface waters.

The CWA made it unlawful to discharge any pollutant from a point source into navigable waters, unless a permit was obtained. EPA's National Pollutant Discharge Elimination System (NPDES) permit program controls discharges. Point sources are discrete conveyances such as pipes or man-made ditches. Individual homes that are connected to a municipal system, use a septic system, or do not have a surface discharge do not need an NPDES permit; however, industrial, municipal, and other facilities must obtain permits if their discharges go directly to surface waters.

NEW TRASH SERVICE

County Hauling is our new trash pick-up service company effective January 1, 2018.

We ask that our residents please adhere to the following ordinances and suggestions when you take out your trash for collection:

- > Place all trash in a secure container
- Take out your trash the night before service, but no earlier than 6:00 p.m.
- Make sure your trash is on the curb or edge of your property (County Hauling will not go onto your property to collect your trash)
