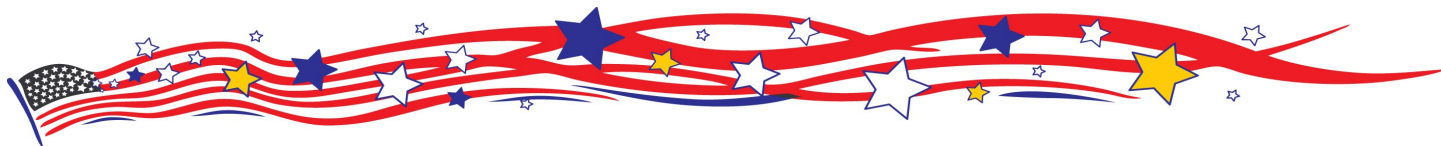


BANQUET LUNCH AT TRINITY LUTHERAN

PASTOR'S MESSAGE

"Pray without ceasing..." (1 Thessalonians 5:17)

"Jesus said to her, 'Go in peace, and be healed'..." (Mark 5:34)

Let us pray...for our nation's health care to be healed.

I'm not trying to "get political" on you. This "affliction" of America not having a reasonable, agreeable, affordable and equitable healthcare system—is in serious need of its own "health" and wholeness.

The system, and all the current efforts underway to change or improve it need our sincere and diligent prayers.

The issue of health care for the citizens of the United States clearly is in the news. It has been ever since the Affordable Health Care Act was signed into law in March, 2010. The very day after its passage was when the first legislation was introduced to repeal it. It has been a contentious issue among us Americans ever since.

Our nation's health care needs our persistent praying.

Actually, the huge obstacle of attaining a national health care plan has existed for every President at least as far back as the presidency of Franklin Roosevelt. Medicare and Medicaid were enacted during Lyndon Johnson's presidency. Otherwise all major national health care reform has eluded accomplishment throughout most all of our lifetimes.

Is there anyone who does not want quality health care to be available, affordable, and accessible for themselves, their families and for all people?

Let us pray for a miraculous healing of our nation's health care.

Is health care meant to be a "commodity" or a "product" within the reach of some American, but not others? Is quality health care meant to be a privilege for an elite few who can afford it? Or should it be a Right for all Americans? Martin Luther King, Jr. wrote: "Of all the forms of inequality, injustice in health care is the most shocking and inhumane."

Our God is not in favor of anything that is unequal, unjust or inhumane.

Let us pray...for God's wisdom and power, and even intervention in healing healthcare in our land.

In fact, in our own Declaration of Independence Thomas Jefferson proclaimed that a "self-evident truth" is that "all humans are created equal," and are "endowed by their Creator with certain unalienable rights; that among these are life, liberty, and the pursuit of happiness." Are there any of us personally for whom health care is not integral to *life* or to our *pursuit of happiness*? I myself cannot confirm the constitutionality of that—but its morality and its spirituality is without a doubt.

Let us all pray for the good, and the right, and the moral outcome for healthcare policy in our land—for us and for all people.

Our nation's health care needs to be healed. This far transcends anything political or partisan, anything commercial or economic. This should be only about doing the right thing for the health care of people—for all people! It is in place and works in other industrialized countries! Who among us could possibly want anything else? How could we possibly pray otherwise?

Let us pray without ceasing. Healing and wholeness is the will of our Lord for us all—and for all people.

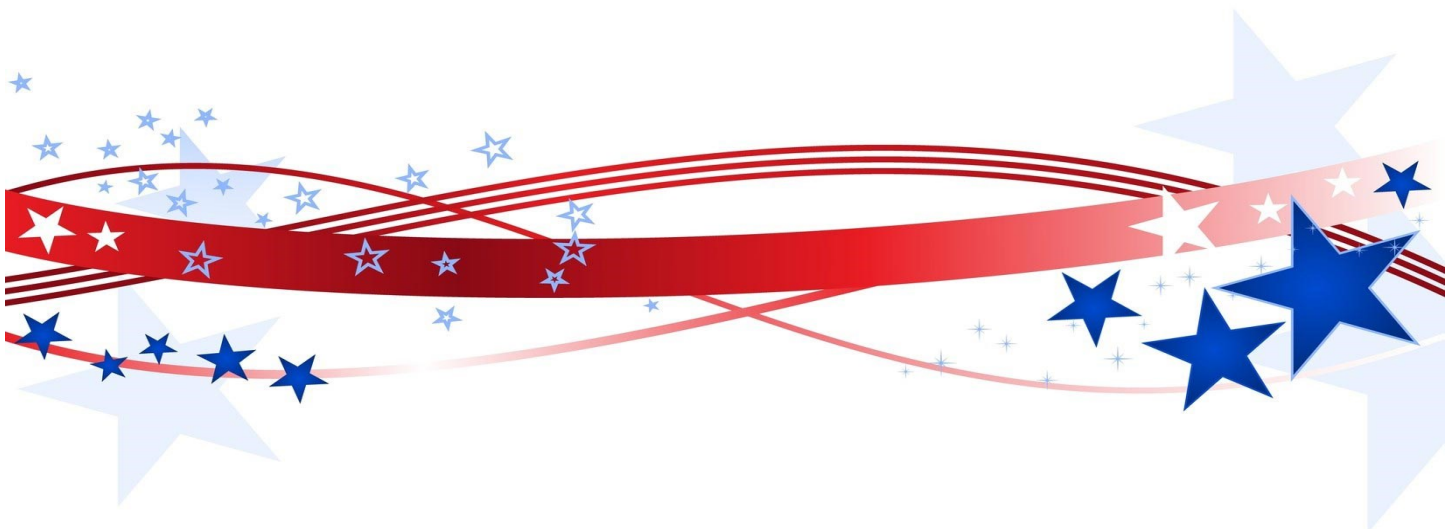
1. Minute for Mission: The committee felt it was important for this to be completed immediately so we can move forward with our goals.

CHRISTIAN EDUCATION

37 incoming 6th-8th grade youth and adults boarded a bus together in Fargo, and headed to Minneapolis for a long weekend of mission work and fun together this past June. Our 32 youth represented 10 different cities, and came together from North Dakota, Minnesota, Presbyterian and ELCA churches! The kids quickly got to know one another, and created great, diverse, friend groups over the 4 days together.

Our first day after travel was spent serving two great charities within the Twin Cities. Our morning



started out with “The Sheridan Story”, a growing organization who responds to the need of the over 200,000 children in Minnesota living in food insecurity, not always knowing where they will receive their next meal. Our youth gathered to learn about the great work The Sheridan Story is accomplishing, and were quickly put to work. I have personally never seen a group of Middle School youth work so hard, and so quickly! Jobs were assigned, got to packing, and finished our goal 30 minutes before expected! Youth packed bags full of protein, veggies, fruit and necessities, in an assembly-like system. There were youth preparing back-up food, making sure every item got recycled, and taken care of. It was incredible work done, and we were able to pack 1,320 packs of food in only one hour!

After our morning spent in Roseville, we visited Galilee Lutheran Church of St. Paul, organizer of the “Rice St. Gardens”. Pastor Dana enthusiastically shared with our youth about her missionary work around the world, and told us of this garden that has been prepared for refugees and immigrants in the Twin Cities. Over 200 plots are available for families to own land, and plant their own gardens. They are in charge of taking care of the gardens, and have created an incredible community within the space on busy Rice St. near St. Paul. Our youth spent time enjoying the beautiful garden space, helping with any clean up needed, but mostly meeting the various garden caretakers from different countries all over the world!





CHRISTIAN EDUCATION



Our last service stop was with “Feed My Starving Children”, who actually has dozens of sites all over the Twin Cities. Our youth learned about the great need of starving children in the world, and the great work FMSC is doing to provide for them. We then packed nutritional meals for families, completing over 100 boxes-which will feed 20,113 people! It was fast paced work, and our kids excelled and enjoyed themselves in this great act of community service.

While our theme was taken from Galatians 5:14-“you shall love your neighbor as yourself”, our youth found great work in providing food for our neighbors in Minneapolis, St. Paul, and all over the world! They were challenged to “love their neighbor” as they got to know 37 different personalities, and deal with a busy, tiring schedule, as we were together for only 4 days, fitting in 3 different mission sites, and visits to Minnehaha Falls, the Mall of America and Valleyfair.

Our Middle School youth did an incredible job on this trip, and were able to learn in their faith from the experience. We look forward to more opportunities for youth to connect within the Presbytery, and in our own youth group here at home!





CHURCH ICE CREAM SOCIAL

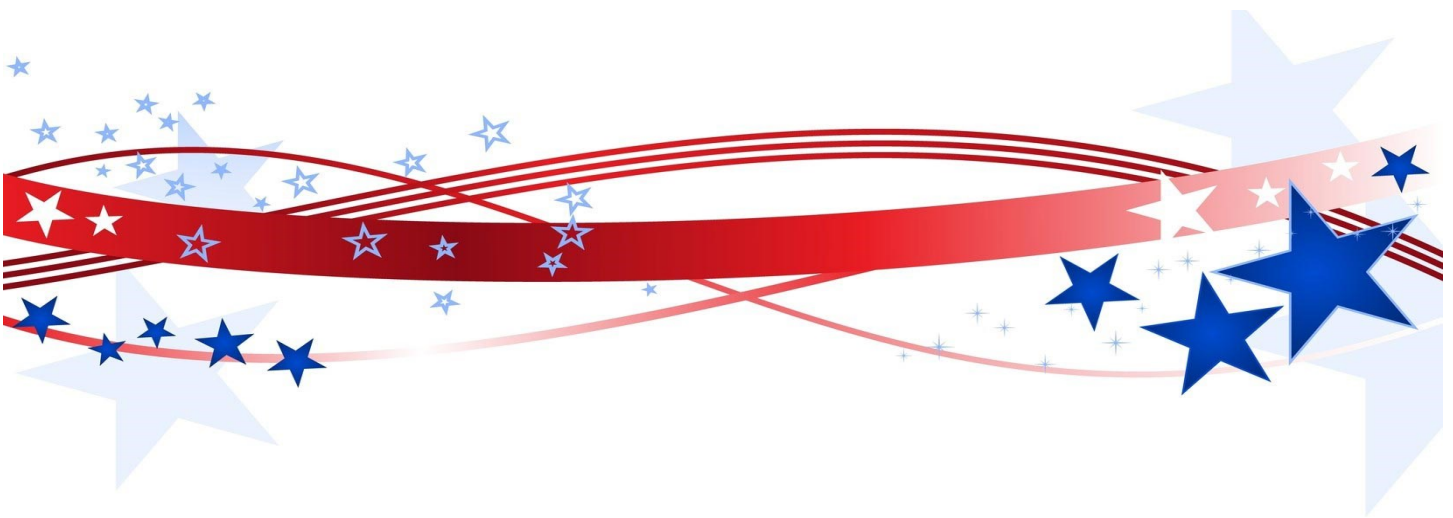

JULY FUN FACTS

- ◆ The birthstone for July is the Ruby.
- ◆ The zodiac signs for July are Cancer (6/21-7/22) and Leo (7/23—8/22).
- ◆ The birth flower for July is the water lily.
- ◆ The month of July was named after Julius Caesar.
- ◆ On July 5, 1971, Amendment 26 was proclaimed setting the voting age at 18 in the United States.
- ◆ The 38th President of the United States, Gerald R. Ford was born on July 1, 1913
- ◆ John Adams and Thomas Jefferson both died on July 4th, 1826. James Monroe also shared the fate of passing on the 4th of July.
- ◆ Calvin Coolidge, the 30th President, was born on July 4th, 1872.
- ◆ The average age of those who signed the Declaration of Independence was 45. The youngest at age 27 was Thomas Lynch, Jr. of South Carolina. The oldest delegate was Benjamin Franklin at age 70. Thomas Jefferson was 33 years old.
- ◆ Only 2 founding fathers signed the Declaration of Independence on July 4th, 1776 (John Hancock and Charles Thompson). The majority of signers penned their signature on August 2nd, 1776.
- ◆ The printed version of the Declaration of Independence was called the Dunlap Broadside; 200 were made but only 27 are accounted for.
- ◆ The original draft of the Declaration of Independence was lost. The one eventually signed is the “engrossed” document.

CHILD CARE CENTER BOARD

Summer Reading: A Brief History of Child Care in the United States

Throughout the nineteenth century, childcare was a matter of mothers finding temporary solutions for child-minding that were as varied in type as they were in safety. Leaving an infant in an unwatched carriage or having an “older” sibling (usually under the age of 10) care for the younger were normal and looked upon as “safer” than the children following their mothers to the factory floors.

Near the end of the century, women’s groups attempted to establish nurseries to help working mothers, but this endeavor was quickly supplanted by growing support of “mothers pensions”, giving monetary support to women as a means of preventing them from seeking outside work and allowing them to focus on rearing their children. By 1930, nearly every state in the union had adopted some type of women’s pension support.

Through the dual effects of the Great Depression (to employ out-of-work teachers) and quickly thereafter, the uptick of World War II labor shortages (recruiting able-bodied mothers) the program of Emergency Nursery Schools was begun, largely run as true schools rather than nurseries, thanks mainly to the formerly-unemployed educators who ran them. However, most childcare centers were woefully under-regulated and under-staffed. Coupled with society’s impressions that children without full-time mothers were being deprived, the childcare reforms struggled to find support.

With World War II coming to a close, funding established for working mothers was quickly cut off, as the country prepared for returning soldiers to replace women on the assembly lines. To continue supporting low and moderate income families, Congress enacted the “child care tax deduction”. Supplemental to that relief was the creation of the ICC—later becoming the Nation Committee on the Day Care of Children. This organization lobbied to fund childcare, stressing safety for children and the need for standardized care in child rearing.

Despite John F. Kennedy’s backing for universal childcare, Congress did not approve a plan. Following Nixon’s veto of the Comprehensive Child Development Act of 1971, the next 30 years would see:

“direct federal support for child care limited to policies “targeted” on low-income families. At the same time, however, the federal government offered several types of indirect support to middle-and upper-class families in the form of tax incentives for employer-sponsored child care and several ways of using child care costs to reduce personal taxes.”

Further, in the 1980s childcare funding shifted focus from low-income families to middle- and high-income families. To the end, several Congressional Acts were passed to help the “welfare-to-work” plan. Most of the smaller programs were merged in the 1990s to form the Child Care and Development [Block Grant] Fund, which provides the primary source of US federal funding for childcare subsidies for low-income working families and funds to improve childcare quality. In 2014, President Obama reauthorized and re-envisioned the CDBG Act to provide further assistance through defining health and safety requirements for childcare providers.



PER CAPITA FEES DUE

Thank you to those who have already paid their family's Per Capita fees. This year, First Presbyterian was assessed \$44.00 per member to help pay for services we receive from the Presbytery, Synod and General Assembly.

If you have not already done so, please take \$44.00 times the number of church members in your family and send a separate check made out to First Presbyterian Church with "Per Capita" in the memo line.

First Presbyterian pays the Per Capita dues regardless of what is paid by church families. The difference between what First Presbyterian owes and what is collected from the congregation will come out of the church budget.

Thank you for taking care of this responsibility so the church can focus on its many other budget needs.

SESSION HIGHLIGHTS JUNE 27TH, 2017

CLERK'S REPORT

Session approved minutes from May 23, 2017 meeting. Membership is 511 as of June 27, 2017. A thank you card was read from the Svihovec family for use of the church for their son's graduation celebration.

PASTOR'S REPORT

Session approved October 29, 2017, to be held after the church service for the **Called Congregation Meeting** to elect officers.

Pastor David informed Session that the Session Minutes book for 1969-1982 is not locatable. Asking if anyone has recollections or ideas of where it might be found.

The Pastor's future time away is scheduled as: July 17-22 MN time and August 11-16 Vacation time.

Discussion was held on Chapter 10 "The Care and Feeding of Spiritual Leaders" of the book *Spiritual Leadership for Church Officers*. This completes the reading of this book.

Business and Finance: Session approval was sought and given to provide \$5,000 for the Search Committee's expenses.

Administrative and Personnel:

A motion was made and approved by Session to have ComputerOne install Wi-Fi throughout the church at the cost of \$7,224.

An applicant for the **Parish Nurse** will be interviewed on July 5, 2017.

A motion was approved to accept the revisions to the **By Laws** and to bring them to the Congregation for approval at the Called Congregational Meeting on October 29th, 2017





SESSION HIGHLIGHTS

A **motion** was made and approved to continue the **Youth Intern Position** for the months of June, July and August.

It was approved for the “ongoing” Facility Request Forms be referred to Admin/Bus. Committee for initial approval and then referred to Session for consideration if appropriate.

Property and Equipment: Matt Engel, chair of P & E, discussed the need to do repairs on the Southwest door by the Child Care Center.

The concrete expands due to water and soil changes causing the door to be comprised. P & E is reviewing the process for repair and will be seeking estimates to make the necessary repairs.

Outreach: The Scholarship Committee awarded the following:

The Jelly Drive for the “Kids Backpack Program” resulted in 220 jars of jelly plus peanut butter and honey, and \$299.00 donated for other food.
