Minutes of September 21, 2020

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Walter Rollin. Also present were Jed Lamb, Robert Holmes, Dimitri Szynal, Frances Rollin, James Lawhead and Sheila Lanning.

**Motion** by Holmes with a second by Lamb to approve the minutes of the September 9, 2020 special scheduled meetings as written. Roll call: 3 yeas. Checks 9254-9258 and payments totaling \$3,175.55 were approved for payment. **Motion** by Lamb with a second by Holmes to authorize **Resolution 2020-45** a contract for deposit of public funds with Farmers Savings Bank from September 30, 2020 to September 30, 2022. Roll call: 3 yeas.

Resident James Lawhead inquired about drag racing on Clark Road. Mr. Lawhead met with Zoning Inspector and inquired about any noise ordinance in the Township. Rollin: no noise ordinance because it is a farming community, tractors, and machinery make noise sometimes at night. Lawhead: called the Sheriff and reported the noise and the drag racing car being taken on Clark Road. Sheriff did talk to resident about a racing car not being legal on roads. Mr. Lawhead: been a resident for 18 years and never had issues until new neighbor moved in this spring. Neighbor has taken the drag racing car on the road at least three times and continually rev up the engine in his garage. Lamb: Unfortunately, people move here and think they can do whatever they wish. Drag racing cars on the road is unlawful so there is no reason to create an ordinance for something that is already unlawful. Suggest presenting a case with all the times and days of the issue to the Sheriff.
