Fire Chief Report

Statistics. In the Month November 2013, Rye Fire responded to 70 calls for service of which 60 were EMS related and 10 were fire related. In comparison with previous year this is an increase of 13% from 2012 and an increase of 24% from the 5 year average of 53.

Administration/Operations. Submitted our Assistance to Firefighters grant. This grant is requesting the funds to purchase Personal Protective Equipment. This includes structural gear also known as bunker gear as well as cycling out our old wildland gear. We also included training

material through the grant which will bring all staff to Firefighter II levels.

Continue to develop SOG's. Obtained job descriptions from Pueblo West and Pueblo Rural, currently tailoring them to fit our staffing.

Hosted a potluck thanksgiving dinner at the fire station for the scheduled crew and their families. Major Event, structure fire in Rye. Nearly all our personnel was committed to this incident and mutual aid was requested and received from Beulah Fire, West Park Fire, Emergency Services Bureau, Pueblo West Metropolitan District and Pueblo County Roads and Bridges.

Prevention. Rye Fire assisted the schools with fire drills. Provided Station Tours throughout the month.

Training. Training has been ongoing throughout the month. Fire training included, PPE, SCBA and fire behavior. EMS training is ongoing with a new topic every 6 days concerning procedure changes, protocol changes and continuing education.

It was noted that Med 11 broke down after transporting a patient to SMC on Sunday and was towed to the City Shops. It was noted that the repairs will be around \$6-8,000. After a discussion, Mr. Scott Carlton will get a price on a new F350 or F450 chassis and Mr. Wills will do more research. It was noted that time was of the essence.

Chief Bennett did a quick review of the Tuttle fire and noted that all personnel are doing fine and Command Staff continues to monitor their situation.

It was noted that the Hatchet Ranch inclusion fee is \$64,000, which includes both sides. A quick review of the proposed budget was done going over several line items. Mr. Elliott noted a concern regarding no contingency for a budget of this side. Chief Bennett noted that the Metro District also doesn't carry a contingency but does budget amendments as necessary. Mr. Schaiberger noted that he would prefer that once the budget gets stabilized that a contingency is established. If the Interagency Program is discontinued, Chief Bennett noted that Rye Fire could be liable for a significant liability.

Hatchet Ranch Update

Mr. Schaiberger noted that a new crane arrives this weekend and will be available to move the large tank the first couple weeks in January. The smaller tanks will be moved at the same time.

Mr. Schaiberger noted that an 8,200 gallon fiberglass tank is now available for purchase for \$5,000. After a lengthy discussion, it was decided that the tanks purchased earlier this year are sufficient and the offer was declined.

Bylaw Revisions

Mr. Schaiberger noted that per SDA, when a new Director assumes a position mid-term, the new Director's term is good only until the next regularly scheduled election. In addition, Directors cannot be reassigned to other positions for the purpose of change in term. Therefore, 4 of the 5 existing Directors will be up for reelection this May. Mr. Wills is the only current Board Member who is not up for reelection. It was noted that the next election for Rye Fire Protection District will be May 6, 2014. An election official will need to be appointed in January 2014. Mr. McGoff was asked to consider the position. More details will be discussed at the January 2014 meeting to comply with election laws, including a time line of events.

Table 1.1, Page 40 of the Employee Manual was revised so that the maximum value that the Fire Chief can expend without prior approval is \$500. Mr. Schaiberger noted that this does not reflect on the correct command staff, but from previous personnel. Chief Bennett was in agreement. No motion was made but was approved by all Board Members with no Aye votes.

The official mailing address has been changed to Colorado City address with an official forwarding card effective for 6-months at the Rye Post Office.

Timing for Appointment of Officers for the Board was discussed at length and will be finalized at the January 2014 meeting.
