- a. Groton billing update survey on SDFFA website to complete for gathering information on SD fire departments processes for billing. More information is needed in order to develop processes, options, and compliance with rules related to billing.
- b. Update and discussion of Spearfish FD news and updates.
- c. Chief Kranz Watertown discussed direct payment discussions for EMS billing
- d. Chief Darrell Hartmann Brookings A volunteer FF hurt knee at fire and filed a work comp claim for injury. He was disabled from regular job. Benefits being paid to the injured firefighter stopped by work comp until they investigated. Work restrictions did not allow FF to return to work but allowed minor tasks and work comp related that being the cause for pay stoppage. Situation rectified after State official involvement and many phone calls and appeals.
 - i. Departments need to make sure they have workers compensation insurance for their members. Discussion about adding it to the requirements to certify a fire department.
 - ii. Chief Gustad -Platte FD pays approx. \$2,500 annually for 34 members to cover the organization for workers compensation insurance.
- e. Chief Kurtenbach Yankton FD Volunteer firefighter EAP options? NVFC has options and Provident who has association insurance has EAP options for organizations and firefighters who need it.
- f. Chief Kurtenbach Yankton FD- discussed the need for trained prosecutors to handle or help local prosecutors with arson prosecution. He will contact SD Attorney General's office for guidance and assistance.
