#10 Bridge Demonstration:

- ❖ Megan started off the Demonstration with a slide show of the existing conditions of the bridge location. She then proceeded with natural resources, hydraulics, project need and desired outcome, VTrans municipal assistance development process, and criteria for alternative investigation. Megan discussed the 3 alternatives for the bridge replacement with the board

members for them to make a decision on what would best fit our situation. The Board were all in agreement to go with Alternative 1. If anyone wishes to see the presentation, it is available in paper form in the town clerk's office.

Other Business:

- ❖ Jennifer Blay joined the meeting to ask the Board 2 Questions
 1. FOLK does a yard sale every year and they had scheduled it the same Saturday as this year rescheduled Town meeting day. She was wondering if they should still hold it that day or if they should schedule it for a different weekend. The Board suggested either changing the date of the yard sale or possibly using the town clerks parking lot instead. Jennifer will discuss it with the rest of the FOLK committee and make a final decision.
 2. The Next Question Jennifer asked was if it is still okay to have a walking trail at the edge of the wood line that would start from the Gelo Park walking trail to the end of the Town property wood line. This Question had been asked a few years ago, and was granted, but there were different board members then. She wanted to have permission from the current board members before they proceeded to do so. The Board asked if they could think about it and get back to her. In the meantime, she can still go ahead and get some Quotes and measurements of what this is going to cost to have done.
