

9/2/2019

Deputy Pennington picked up a stray dog on Stonehouse Road and took it to the dog pound.

Deputy Blamble assisted the Woodsfield EMS with a patient life flight in the Clarington area.

Deputy Blamble assisted Sgt. Warner and Deputy Schuerman with a crash investigation on Baptist Ridge Road.

9/3/2019

Deputy Schuerman and Deputy Harr responded to a residential burglary alarm on Center Ridge Road. The residence was found to be secured, but evidence was found of an attempt to gain entry. The Monroe County Detectives are also working with PA and WV law enforcement in reference to several B&E's in their jurisdiction that links them to the property that our Deputies recovered.

Sgt. Peska and Deputy Cline responded to a harassment call on Big Injun Road. Upon arriving at the residence, the suspect had left and returned to Noble County. Investigation is pending.

Sgt. Peska responded to a burglary alarm on County Road 84. Upon arriving at the residence, the alarm was set off by the owner.

Deputy Miller and Sgt. Galloway responded to a Hanson Ridge address for a 9-1-1 hang-up. After speaking with the homeowner, they advised of having trouble with an Apple watch calling emergency contacts.
