## ADOPTING RULES FOR USE OF PORT PROPERTY AND REQUESTING SHERIFF ENFORCEMENT

WHEREAS, pursuant to RCW 53.08.220, a port district may formulate needful regulations for the use of any properties or facilities owned or operated by the Port of Manchester, and such needful regulations may be adopted through ordinance, resolution, or mutual agreement with the Kitsap Sheriff's Office, and

WHEREAS, The Port of Manchester joined with other port districts in Kitsap County to request the county to adopt a set of uniform regulations applicable to the port districts, with violations an infraction or misdemeanor, but the Kitsap County Sheriff's Office suggested an alternative whereby each port district could adopt its own rules and request enforcement by the Kitsap County Sheriff and the Sheriff's office would acknowledge that such rules were subject to enforcement by the Sheriff's office;

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Port of Manchester that:

- 1. The attached "RULES FOR USE OF PORT PROPERTY" are adopted By the Port of Manchester; and
- 2. The Kitsap County Sheriff's Office is authorized to enforce the rules on Port Property and is requested to acknowledge having authority to enforce the rules.

#### RULES FOR USE OF PORT PROPERTY

#### A. GENERAL RULES

- 1. Facilities are open during daylight hours only
- 2. A dumpster is provided for all boating and park garbage
- 3. All pets must be on a leash while on Port property

#### B. VEHICLE RULES

- 1. Parking is allowed in designated marked spaces only
- 2. A 5 mile per hour speed limit must be observed
- 3. Overnight parking is allowed in accordance with most recent adopted Resolution of the Port.

#### C. LAUNCH & MOORING AREAS RULES

- 1. The facilities are closed from dusk to dawn except for launch/recovery
- 2. There is a fifteen minute limit on mooring in the yellow zone
- 3. No swimming is allowed between floats.
- 4. Fishing is allowed on the South float only
- 5. Leave no wake in vicinity of docks or floats
- 6. No smoking allowed anywhere on Port property

#### D. ACTIVITES PROHIBITED IN ALL PORT AREAS

- 1. No skateboards, scooters, bicycles or other wheeled vehicles are permitted on Port property
  - 2. No open fires or fireworks permitted on Port property
  - 3. No alcoholic beverages or unlawful drugs permitted on Port property

# E. PORT PERMISSION IS REQUIRED FOR ALL COMMERCIAL OR GROUP ACTIVITIES WHICH MUST BE OBTAINED IN ADVANCE
