MINOR'S RELEASE ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

We the undersigned hereby request that the below named minor (minor) be granted permission (1) to enter the restricted area, (2) to participate as a contestant, assistant, official, or otherwise in rodeo events, (3) to compete for money, prizes, recognition, or reward, (4) to be covered by participant's hospitalization insurance, if applicable, as limited by master policy (all collectively herein called permissive entry)

In consideration of "permissive entry" to minor into the restricted area, which is the arena form which admission to general public is restricted, which includes but is not limited to the rodeo arena, competition area, chutes, pens adjacent walkways, concessions, and other appurtenances, we the undersigned on behalf of the minor, and ourselves, our personal representative, heirs, next of kin, spouses, and assigns, do hereby.

1. **RELEASED DISCHARGE AND COVENANT NOT TO SUE** the rodeo committee, stock contractor, rodeo association, sponsors, arena operators, or owners and each of them, their officers, agents, and employees (all herein collectively referred to as "releases") from any and all claims and liability arising out of the strict liability or ordinary negligence of releases or any other participant which causes the undersigned injury, death, damages, or property damage. We the undersigned jointly severally, and in common covenant to hold releases harmless and to indemnify releases from any claim, judgment or expenses, releases may incur arising out of any of the minor's activities or presence in the restricted area.
2. **UNDERSTAND** that the minor's entry into the restricted area and/or participation in the rodeo events contains **DANGER AND RISK OF INJURY OR DEATH TO MINOR**, that conditions of the rodeo arena change from time to time and become more hazardous, that the rodeo animals are dangerous and unpredictable, and that there is **INHERENT DANGER** in rodeo which we each appreciate and voluntarily assume because the minor and we choose to do so. Each of the undersigned has observed events of the type that the minor seeks to participate in. We further understand that the arena surface, access ways or lack thereof, lighting, or lack thereof, and weather conditions all change the pose a danger to the minor. **WE EACH OTHER VOLUNTARILY ELECT TO ACCPET ALL RISKS** connected with the minor's entry into the restricted area or unrestricted areas and or participation in any rodeo events.
3. **Releaser or parents or guardians of the undersigned minor AGREE TO INDEMNIFY** the releases and each of them from any loss, liability, damage or cost they may incur due to the presence of participation of the minor in the described activities whether caused by the negligence of the Releases or otherwise.

Description of Event

I/WE HEREBY RELEASE, WAIVE, COVENANT NOT TO SUE AND DISCHARGE the promoter, participants rodeo association, association directors and board members, sanctioning organization or any subdivision thereof, arena operator, arena owner, officials, other participants and any persons in restricted area, promoters, sponsors, advertisers, owners, lessees of premises used to conduct the event and each of the heir officers, and employees, all for the purpose therein referred to as the "Releasees", from all liability to the undersigned my/our personal representatives, assigns, heirs, and next of kin for any and all loss or damage and any claim or any demand on account of any injury to the participant included but not limited to death where caused by the negligence of the "Releasees" or otherwise while in the minor is in or upon the restricted area and/or competing, officiating in, observing, working for, or for any purpose participating in the event.

The Restricted Area is defined as the arena, chutes, staging areas, approaches thereto and all walkways, concessions, and other areas appurtenant to any such area where any activity related to the event shall take place.

I/We will inform and instruct the said minor participant that upon entering any restricted area the minor must continuously thereafter inspect such restricted area and all portions thereof which the minor enters and with which he comes in contact and I/we further warrant that the minor's entry upon such restricted area or areas and his participation. If any in the event constitutes an acknowledgement that he, (the minor) has inspected such restricted area that he finds and accepts the same as being safe and reasonably suited for the purpose of his use, and further agrees and warrants that if at any time he is in or about restricted areas and if he feels anything is unsafe, he will immediately advise the officials of such and will leave the restricted area.

The undersigned expressly acknowledge and agree that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage.

Each of the undersigned parents or legal guardians for the minor participant agrees to indemnify and save the hold harmless the "Releasees) and each of them from any loss, liability, damage or cost they may incur due to the presence of the said minor in or upon the restricted area or in any way competing, officiating, observing, or working for any purpose participating in the vent and caused by the negligence of the "Releasees" or otherwise.

THE UDNERSIGNED PARENTS OR LEGAL GUARDIANS HAVE READ AND VOLUNTARILY SIGN THE MONOR RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT AND FURTHER AGREE THAT NO ORAL REPRESENTATION, STATEMENTS, OR INDUCEMENTS APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE.
