APPROVE AND OR DISCUSS LEASE PURCHASE OF 2020 POLICE INTERCEPTOR EXPLORER; AND TRADE IN. Mallory gave update on 2012 car. Oil change was done and hardly anything in the oil. Reed Auto stated nothing needs to be done. Central Bank has cheapest interest rate at 3.75%. Amount for car and having it fitted approximately \$38,000 minus trade in at \$6,000. Questions regarding if trade in will still be \$6,000. Danderson wants dealership to know the car was tore up. Icenhower stated he is still in favor of buying used Highway Patrol cars; Dodge Chargers at \$18,950. Mallory does not want chargers, they are not any good. Highway Patrol Explorers are \$21,500 with approximately 60,000 miles on them. Questions on financing car was discussed. Usually the outfitting of the car is added to the lease purchase. Clerk thought it would be cheaper for the city if we used city money to make down payment and outfit the new car along with trade-in then only have two more payments. Joe Machen's Ford has lowest bid at \$33,677.

Motion by Roe to approve lease purchase of 2020 police interceptor Explorer Joe Machen's Ford with minimum trade-in of \$3,100 for 2012 Dodge Charger; including financing at Central Bank at 3.75% interest. Second Faherty. Discussion: Danderson wanted to know if Joe Machen's Ford will still honor quote if city doesn't finance through them. Mallory yes.
