#### **NASCOE Myths: Debunked**

#### A Message From Your President-Jessi Colgrove

The NEBRASCOE Board of Directors has been working to debunk some of the more common myths about NASCOE membership. In past issues of the NEBRASCOE newsletter I discussed "but I don't want my membership dues to pay for you to go on trips" and "something happened that upset me". This time we will focus on a common misconception: "I don't need to pay dues because I get the same benefits as members". Illinois IASCOE President Debbie Staley wrote an amazing analogy called "Home on the Riverbank" that explains why everyone should be a member. This article is used with her permission and blessing.

#### **Get To Know a NEBRASCOE Member**

#### Long Tradition of Farming in Nebraska and the Midwest

Iye udo<sup>n</sup> egitho<sup>n</sup>! Ponca izha wawitate Wau No<sup>n</sup>de I<sup>n</sup>gthu<sup>n</sup>huto<sup>n</sup>. Waxe izha wawitate Angie Teboe. Usni Ponca bthi<sup>n</sup>. Nudo<sup>n</sup>ho<sup>n</sup>ga go<sup>n</sup>tha Cedar County bthi<sup>n</sup>. O<sup>n</sup>bathe wibthaho<sup>n</sup> iye.

Greetings! My Ponca name is Woman Whose Heart Thunders. My English name is Angie Teboe. I am a member of the Ponca Tribe of Nebraska. I am the County Executive Director for Cedar County and a member of NASCOE. Thank you for letting me speak with you today.

I have had the pleasure of being involved with agriculture since childhood, growing up on a crop and livestock farm in Pierce County. I am honored to have worked for FSA for the past 8 years. Not only has farming in Nebraska been a fourth generation tradition on my father's side, but has been at least a 300 year tradition in Nebraska and at least 1000 years in the lowa and South Dakota for my mother's side, my Ponca side. There are currently Ponca still farming in Nebraska, traditional and modern farming. Ponca Gray Corn (aka Ponca Blue Corn) is still planted in Nebraska.

We, Ponca, had large scale gardening aka small scale farming of primarily corn, squash, and beans, which we planted in the rich river bottom ground. We supplemented our crops, with foraged plants, fish, and wild game as well as biannual bison hunts. We also harvested salt in the Lincoln, NE area. The land, water, and resources are held in high regard and our connection to it is essential to our identity as Ponca people. As part of treaties with the U.S. government, we, Ponca, incorporated modern farming like those of the settlers around the Ponca reservation near Niobrara, NE.

In 1877, our Ponca people were forced to leave Nebraska for Indian Territory, now Oklahoma. When our chiefs saw the Oklahoma ground that was supposed to be a fair trade to our lands in Nebraska, they refused as it was nowhere the rich and plentiful ground of Nebraska. However, we were moved there, regardless. Some Ponca remained in the Niobrara area illegally and through the death of Chief Standing Bear's son and the subsequent (continued on page 5)

federal trial which declared Natives as people in eyes of the law, our Ponca people are now split into two groups: the Maste Ponca (hot – Ponca Tribe of Oklahoma) and Usni Ponca (cold – Ponca Tribe of Nebraska).

This past May, we, Ponca, held a remembrance walk of that forced removal. We walked 280 miles in 12 days from Niobrara, NE to Barneston, NE and stayed close to the trail we would have taken when forcibly removed from Nebraska in 1877. We were able to pay our respects to the Ponca that died along the trail and have a very small taste of what the removal felt like. I completed 8 days and 180 miles of the walk. I was able to take in our beautiful Nebraska land and watch the planting season progress. All the towns we stopped

and camped in were very hospitable and we greatly appreciated their kindness.

I encourage you to visit the following informative places about the Ponca Removal: Ponca Tribe Museum – Niobrara, NE; Antelope County Museum – Neligh, NE; Standing Bear and Ponca Tribe Historical Marker – Interstate 80 Rest Area Milford, NE; and the Chief Standing Bear Trail - 19.5 mile walking/biking trail from Beatrice, NE to Barneston, NE; as well as online at the virtual Ponca Removal Trail: <a href="http://www.chiefstandingbear.org/">http://www.chiefstandingbear.org/</a> and the Ponca Tribe of Nebraska website: <a href="https://www.poncatribe-ne.org/">https://www.poncatribe-ne.org/</a>. A big shout out to fellow FSA employee and NASCOE member, Jessi Colgrove, Gage County CED, for completing the last day of the walk with me!

Just as my Ponca people value and respect the land, animals, and resources of Nebraska, our current farmers and ranchers in Nebraska do also and I am privileged to be a part of that through the humble task of administrating FSA

programs. I extend my thanks to you, my fellow FSA employees, for your part in being caretakers. Wibthaho<sup>n</sup>!

### From the NEBRASCOE Cookbook

#### Perfect Dill Pickles

- Pickling cucumbers
- 6 1/2 c. water
- 1/2 c. salt
- 3 c. vinegar
- 1 tsp. powdered alum
- 1 Tbsp. Sugar
- Dill
- Cloves of garlic

Boil this for 15 minutes. Pack cucumbers in jars with lots of dill. Put in a clove of garlic per jar as well. Add 1 Tbsp. Sugar to each quart (do not boil sugar). Pour the boiling vinegar brine over cucumbers. Fill to top of jars and seal tight. Set the jars in boiling water to come over tops of jars. Cover. Turn the burner off and let stand till cool, then remove.

#### **NEBRASCOE Membership Down in 2017-2018**

Summer is a busy time, both in our FSA offices and at home; so I just wanted to get a reminder out to all county office employees that our new fiscal year for NASCOE started July 1, and as such, NASCOE/NEBRASCOE dues should be paid at this time. Our NEBRASCOE membership is down a bit from where it was last year from 68% to 62%.





Last year 201 of the 296 county office employees were NASCOE/NEBRASCOE members as compared to the 184 members we have at this time. Nearly 11% of our membership in 2016-2017 has now retired with only 2% of our new employees joining NASCOE.

It's not too late to renew your NASCOE dues or become a new NASCOE member. Dues can be paid by check for the entire fiscal year or by filing an FSA-444 to have dues reduced from your salary on a per pay period basis. Checks can be mailed to:

#### **North West Area Rally Wrap-Up**

The 2017 North West Rally was held in Lincoln, NE on April 27-29. Please read below for the details.

Chris Beyerhelm, Acting FSA Administrator attended the Rally in Lincoln and touched on Budget/ Staffing, Programs/Software, IT, Personnel/Training and other miscellaneous items.

Cash Awards are staying. The amounts were less this year than last year; but the cash awards process will be staying in place. Awards are budget-driven so availability of 'spot awards' will depend on budget. We were at 98.5% of our staffing ceiling prior to the hiring freeze (11,800 employees) with a budget of \$1.6 Billion (\$1 Billion is Salaries)

Within FSA there is a need to make people want to stay in their job and to make them feel valued. Through the recent Viewpoint Survey it was reported that 60% of FSA feel their supervisors don't have honesty and integrity.

Updating handbooks is a work in progress. It is the goal of WDC to keep offices up-to-date on program provisions/procedure, not only with Notices, but ultimately with up-to-date handbooks.

ARS is our workload delivery system and it needs to be tweaked. Work is needed to hone a process to analyze workload and to deal with the complexity of producers and operations. With this in mind, employees should be very diligent and detailed in their ARS reporting so that ARS reflects true areas/ programs worked each day/each pay period throughout the year. That is important when budget/ funding is determined. It is also very important to record all hours worked—and hours worked beyond normal tour of duty should be recorded as credit time, comp time, etc. It's the only way to record the number of hours required to complete the work we do throughout the year and it effects programs and funding tremendously. We continue to get the job done and that is hurting "our story" to tell Congress that we need more budget to hire more people. As long as we continue to get the job done then Congress won't be able to see that we are struggling.

Refreshing Computers: WDC plans to 'refresh' computers every 3-4 years. They want to inventory

what is in each office and see what is needed (laptop vs desktop) depending on how/where the employee is working. One size does not fit all and smarter IT purchases will be made.

By the end of the fiscal year IT is planning to have a Dashboard to monitor IT issues up and down the line so that if there are problems they can be identified and addressed more quickly.

PT Counter Skills is in the development phase right now. The need to train Program Technicians was voiced in employee surveys.

Farm Bill: WDC is in the information-gathering and ideas stage of the new farm bill. They're working to decide what programs to keep as is; what programs to tweak and keep and what minor programs are not feasible to keep due to the budget.

Steve Peterson, Division Director for Production, Emergencies and Compliance Division, also joined the meeting and spoke at the rally about the following:

Changes looked at for new Farm Bill:

ARC/PLC - using NASS vs RMA production to set yields?

CRP – nation is nearing the 24 million acre cap – as we near the acre cap, what changes will be made?

ELAP – should funding for this program be increased?

Re-iteration that Receipt for Service is here to stay for as long as it stays in statute language.

LFP has issued \$6.2 Billion in payment since it started (as of April 2017).

NAP-Buy-Up coverage may not continue in the next farm bill.

Other NASCOE items discussed were:

**PROGRAMS:** 102 program ideas/suggestions, across the country, were submitted during the year. Submitting suggestions is an on-line process and can be completed on the NASCOE website.

**MEMBERSHIP:** The Northwest Area has 75 percent membership in NASCOE.

**BENEFITS:** Dillard Financial Solutions Inc. is in the sixth year of its contract as the exclusive benefits counselor for NASCOE. Work is in progress on a "Quick Guide to Benefits". A reminder was given for NASCOE members to review and use Working Advantage (<a href="www.workingadvantage.com">www.workingadvantage.com</a>). A NASCOE ID # is needed to access the account. Contact a NEBRASCOE board member to get the ID#.

**AWARDS/SCHOLARSHIP:** Nominations for awards and applications for scholarships were submitted on-line for the first time this fiscal year. Members are encouraged to review scholarships available and submit applications timely. Members are also encouraged to submit nominations of NASCOE members for Distinguished Service Awards in three categories (Service to the Community, Service to FSA and Service to NASCOE). (See the NEBRASCOE website for a list of this year's Scholarship and DSA recipients.)

**CANDIDACY ANNOUNCEMENTS:** Candidates for NASCOE Election announced their candidacy for NASCOE President, Vice-President, Secretary and NWA Executive. Elections will be held during the National Convention.

**CONVENTION & RALLY UPDATES:** The 2017 National Convention will be held in St. Charles, MO from August 2<sup>nd</sup>-5<sup>th</sup>. The 2018 National Convention will be in Sioux Falls, SD from August 1<sup>st</sup> thru 4<sup>th</sup>, 2018. Details will follow when available. The 2018 NWA Rally is being planned for Bellingham, WA in mid-April 2018. Details will follow when available.
