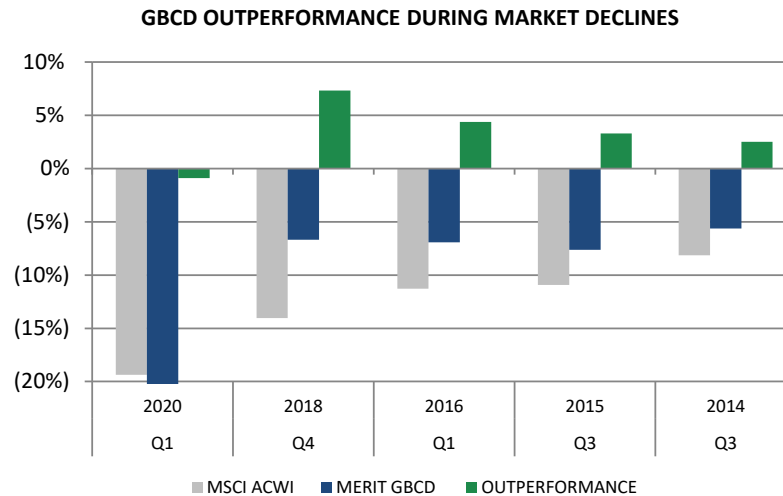
HISTORICAL PERFORMANCE ANALYSIS

ILLUSTRATIVE HISTORICAL PERFORMANCE

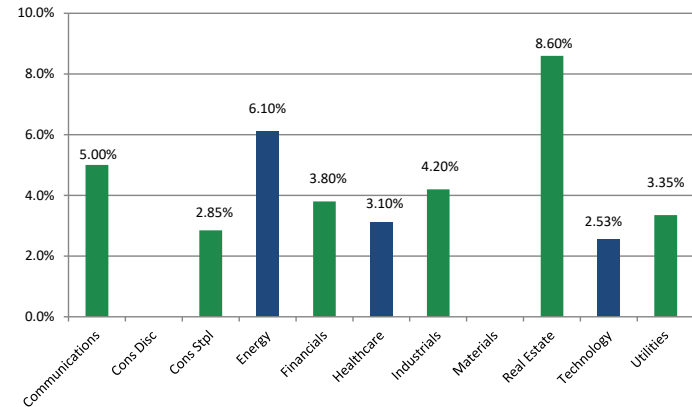
DIVIDEND YIELD & RISK METRICS

DIVIDEND METRICS

- All positions have stable yields & high dividend health scores

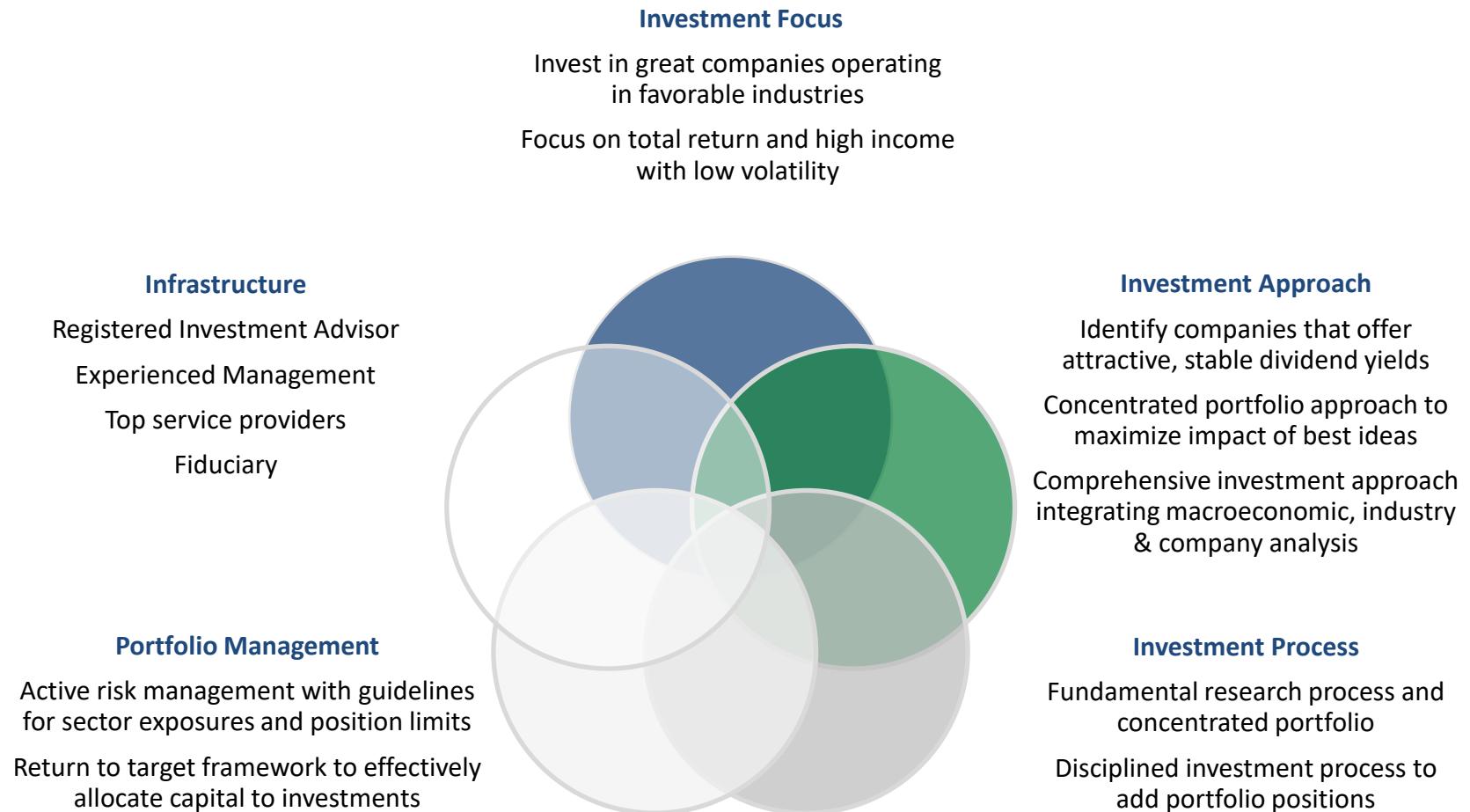
