Parkland County, Safety Codes Services – further to our meeting at the Parkland County office, attached is a proposal from Parkland County to provide the safety codes inspections and permitting for the Summer Village of South View. e) Lot Development Proposal – The property owners of 9925-101 Ave. are requesting consideration be given to the attached proposal for some drainage work along Oscar Wikstrom Drive. The details are attached; essentially the proposal is to allow for a swale between 9921-101 Ave and 9925-101 Ave which would collect the runoff from the neighbouring lots and direct the water onto the adjacent reserve property. The change in water flow and proposed tree removal warrant consideration of Council, however Development Officer Burtnick has submitted her recommendation for your consideration which includes allowing the owners to build up their lot (at their cost) and that any tree removed on the reserve be replaced by a sapling of the same kind (approve either proposal or some other direction as warranted)

2017 Draft Operating Budget – attached is our draft budget, based on all previous discussions. Administration will be asking for Councils' consideration to approve this budget. This budget has an increase in municipal tax dollars collected of 1.8% (\$2,913.00), school decrease of \$7% (\$3,243.00) and seniors decrease of 7% (\$286.00) for an overall tax increase of 0.3% (\$615.00). The decrease in School and Seniors is because our overall assessment went down when compared to others, and these two requisitions are based on equalized assessment. The Summer Village has no control over either of these, we are simply collecting these funds as required. We are still collecting \$45.00/parcel for the lagoon reserve and the minimum tax is still at \$950.00. (approve budget as presented)
