VIRGINIA

The tenth of the original thirteen Colonies, the district courts in Virginia were organized under the Judiciary Act of 1789 as a single district.¹ The Western District was created in 1819, and given a new judgeship.² This district, in turn, became the District of West Virginia in 1864, and Virginia reverted to single-district status.³ The line occupied by Judge Jackson (VA.WD.01) was transferred to West Virginia as a result.⁴ Reorganization into the Eastern and Western Districts followed in 1871, with each district assigned one judgeship.⁵

VA.ED.01 is the original judgeship (see Judge Griffin's succession line), which served the entire state until the line was transferred to the Eastern District in 1819, only to revert back to the District of Virginia when West Virginia was created. The judgeship was assigned permanently to the Eastern District in 1871. VA.ED.10 was created as a temporary line in 1990; its authorization was amended in 1997,⁶ and subsequently made permanent in 2002.⁷

VA.WD.04 was authorized under disability provisions established under Title 28,8 under which the President can appoint a temporary judge. When Judge Michie (VA.WD.03) died in office, that line ended and VA.WD.04 effectively became a regular seat.

Virginia is in the Fourth Circuit and has fifteen positions—eleven in the Eastern District, and four in the Western.
