**ARUCC AND PESC PARTNER TO ADVANCE HIGHER EDUCATION
PARTNERSHIP EXPANDS ROLE AND IMPORTANCE OF CANADIAN PESC USER GROUP**

(Ottawa) - The Association of Registrars of the Universities and Colleges of Canada (ARUCC) and the P20W Education Standards Council (PESC) are pleased to announce a new strategic partnership that will advance higher education throughout Canada and the United States of America.

Under the agreement, both associations will work together to enhance the profile of and raise standards within the profession of higher education administration and management. Both associations share a common dedication to the continued development of professional administrators and managers supporting higher education and to the promotion of the highest standards of fair, ethical and transparent professional behaviour.

The goal of a partnership will be facilitated through the exchange of information, consultation and appropriate collaborative projects. Effective immediately, an ARUCC representative will join the Canadian PESC User Group which will serve as the primary contact between ARUCC and PESC.

“ARUCC is pleased to partner with PESC to collaborate and raise electronic data sharing standards within the profession,” states Hans Rouleau, ARUCC President and Registrar of Bishop’s University. “The work of PESC is vital to ARUCC members because it allows universities and colleges to share data in a safe, reliable and affordable manner. We look forward to working with PESC on the next phase of developing a Canadian Transcript Exchange Network.”

“This partnership is significant in helping us move forward to have common interoperable standards for data and data exchange for Higher Education in Canada,” adds William McKee, Director of Operations for the Ontario College Application Service (OCAS) and Chair of the Canadian PESC User Group. “The initial focus of the user group was education on PESC and its benefits to Canadian education institutions and suppliers for data and data exchange for Higher Education. We are now focused on a Canadian Transcript Exchange Network.”

The Canadian PESC User Group participants include representatives from ApplyAlberta, Association of Registrars of Colleges and Universities of Canada (ARUCC), BCCampus, Ontario Ministry of Training for Colleges and Universities (MTCU), Ontario College Application Service (OCAS), Ontario Universities’ Application Centre (OUAC), Statistics Canada, Ellucian, Maplewood Computing, Trevlac, University of British Columbia, University of Regina, University of Waterloo, Conestoga College, University of Toronto, York University, McGill University, Memorial University of Newfoundland, Université de Moncton, Wilfred Laurier University, Royal Roads University, University of PEI, New Brunswick Council on Articulation & Transfer, and University of Lethbridge. The User Group is also conducting

outreach to their respective membership organizations and other stakeholders such as The Canadian University Council of Chief Information Officers (CUCCIO). The User Group meets bi-weekly by Web conference call and meets in person during PESC's Spring and Fall Data Summits.
