Hauled mix for ice control from Odessa sand and stone, this is a fine stone dust at \$6.50 a ton compared to washed sand for \$12.75 per ton. 2. started ditching and cleaning shoulders on Beaver Dams-Moreland Road and Price Road to prep for road projects. 3. Been taking deliveries for the new town hall and putting them in judges chamber and supervisor's room. 4. Went to Albany to advocate for more highway funding. 5. Found a failing culvert pipe on Beaver Dams-Moreland Road, ordered pipe so we can change it out ASAP 6. Been doing a traffic count for Allen Rd to see vehicles and how many. We will be conducting this for a month or two to get an average daily amount 7. Soil and Water touched base at a meeting about hydro seeding the new town hall. Supervisor Smith has been working with Jerry. Let Jerry know when you're ready so he can get it done. 8. Completed first round of sweeping of roads, had to order some new bristles for the sweeper, seems to be working pretty well
