The holiday season often ends with a new addition to the home in the form of a cat or dog. The Deed Restrictions in all sections of Sugar Mill limit the number of animals in

each home to three (3). Cats need to be contained within the yard as the City of Sugar Land Animal Services says that a high percentage of the cats in the shelter are from Sugar Mill. If you are missing your indoor/outdoor cat, please go to the Shelter and rescue them. Upon doing so, have a microchip inserted so that you can be notified of your missing feline.

Dogs are a great source of joy and they encourage us to exercise. We would like to remind all of our residents that the City of Sugar Land has the following ordinance on our canine friends:

### **Pet Waste Ordinance**

Sec. 3-13. Animal Waste Disposal

• It is unlawful for an owner or person having control of an animal to permit the animal to defecate on private property unless the person immediately removes and properly disposes of the feces.

• It is unlawful for an owner or person having control of an animal to walk the animal on private property without carrying at all times a suitable container or other suitable instrument for the removal and disposal of animal feces.

• Prior to filing a complaint with the city, the person whose property has been defecated on must give written notice to the owner or person having control of the animal that the animal defecated on the property and the owner or person having control of the animal failed to immediately remove and properly dispose of the feces. A copy of the written notice must be presented to the city at the time of filing the complaint.

It is a defense to prosecution under this section that the animal is a specially trained dog that is being used by a blind individual.
It is a defense to prosecution under this section that the animal defecates upon private property owned by the owner or person having control of the animal. (Ord. No. 1722, § 1, 12-16-2008)

Please carry the necessary plastic waste disposal bags when walking your dogs - it is the neighborly thing to do!

## City To Present State of the City Address - January 24th

Sugar Land will partner with the Fort Bend Chamber of Commerce to present a State of the City Address focusing on its 2013 accomplishments.



This is the sixth year that the city has presented an annual summary of activities to residents.

The community is invited to attend the Jan. 24 program at the Sugar Land Marriott Hotel and Conference Center, 16090 City Walk at the corner of U.S. 59 and Texas 6.

Breakfast will be served at 7:30 a.m., followed at 8 a.m. with a presentation of 2013 Sugar Land achievements. Some of these include the following:

In fiscal year 2013, Sugar Land announced several significant relocations, including Fortune 500 firms that operate internationally as well as other national and local firms. These combined projects will result in more than \$23 million in new capital investment, 1,225 new and 150 retained jobs and more than 266,000 square feet of newly constructed or newly leased space.

Sugar Land also approved a design contract for a new performing arts center. The approximate 6,500-seat venue will be located on a portion of 38.5 acres of city-own property in the Telfair commercial district, southeast of U.S. 59 and University Boulevard.

## Marion's Fishing Corner

### A GOOD TIME TO SLOW DOWN

Wintertime is here, and as I've said before, the next two months will be the toughest time of the year for anyone wanting to catch fish. With our water temps hovering around 50 degrees, the fish are very inactive and require very little food intake. Their bodies are in energy-conservation mode, and need very little nutrition. When they do eat, the digestion process takes considerably longer, so this prolongs the time between meals.

I'm sure we will have some short stretches of warm days on occasion during the coming months, but for the most part, I think our overall water temps will stav low until we reach spring. On larger, deeper lakes, gamefish under these conditions will relocate out into deep water. There they can normally find slightly warmer water that is insulated from the harsh, cold surface waters. They usually will remain there during most of the winter, only to move up shallower as temperatures start to moderate. But with the deepest water in Misty Lake averaging about 10 feet, our gamefish don't have that luxury. Our water temperatures are usually the same from the surface to the bottom during the wintertime. So the fish usually hunker down in some type of structure and just try to conserve body mass until conditions improve.

Fishing this time of year can be very humbling. Sure, fish can still be caught on occasion after a few warmer days, but generally, success rates are very low. The best advice would be to fish slow, slow, slow. Fish are not willing to chase down a meal, so slow methodical retrieves are the order of the day. This is also a good time of year

to experiment with different styles of baits. There are normally two trains of thought among bass anglers this time of year. Some anglers choose to use large 8" to 10" plastic worms or lizards to provoke a "reaction" strike from large fish that prefer a large meal. Other anglers believe that smaller 6" to 4" finessestyle baits will increase their odds for catching lethargic cold-water fish. This is a good time to try both, and form your own opinion.

So if you are willing to put up with the inconveniences of cold weather and sluggish fish, give it a try. You just might catch the biggest fish of your life. And if you do, remember to release her gently, because those big brood fish are the future of our lake.

Remember to catch and release, because a bass is too valuable of a resource to catch just once.

### Sugar Land's Performing Arts Center Update

Sugar Land City Council approved on Dec. 17 a Construction Manager at Risk (CMAR) agreement that includes pre-construction services in the amount of \$98,500 with Linbeck Group, LLC for the City's new performing arts center.

The approximate 6,500-seat venue will be located on a portion of 38.5 acres of Cityown property in the Telfair commercial district, southeast of U.S. Highway 59 and University Boulevard.

Utilizing a CMAR process will enable Sugar Land, the design team and the construction manager to work together to ensure design decisions can be efficiently implemented into the construction project within an established budget and project timeline.

The CMAR team will work to ensure Sugar Land's venue incorporates industry-wide best practices, durable construction, a layout that's easy to operate and maintain the acoustics and sightlines that accommodate a wide range of performances. The process will result in a guaranteed maximum price for construction.

Construction is expected to begin late next summer and take about 24 months. Development near the venue will include a public plaza surrounded by commercial, office and entertainment projects.

### Sugar Land's Land Use Forum

The Land Use Forum -- a sixpart speakers' series highlighting land-use topics such as housing choices, development of activity centers and redevelopment of aging commercial areas in Sugar Land -- is scheduled to begin Jan. 15. 




