**RECEIVER'S SUPPLEMENT TO HIS MOTION TO AUTHORIZE
A SUPPLEMENTAL DISTRIBUTION PURSUANT TO
THE PLAN OF DISTRIBUTION**

Eduardo S. Espinosa, in his capacity as the court-appointed Receiver for Retirement Value, supplements his motion for authorization to make a supplemental distribution to the Investors¹ pursuant to § VII of the Plan of Distribution.

This supplement provides further explanation as to three issues which affect the amounts distributed to several Investors.

1. Settlement Agreements. A number of the settlement agreements between the Receiver and Licensees call for the settling licensees to pay the estate out of distributions they or their family members receive as investors. Each of these settlements was previously approved

by the Court and similar repayments were made out of the Initial Distribution. The attached payment schedule (Amended Exhibit B) identifies the Investors whose distributions are affected by settlement agreements and shows the allocation of the distributions between the estate and the Investors. Out of this proposed distribution, an aggregate of \$32,267.44 will be paid to the estate pursuant to settlement agreements.

2. Joyce Hipp

Joyce Hipp's entire claim of \$699,845.70 against Hill Country Funding was initially titled in the name of "Joyce Hipp (IRA)." Subsequent to the Initial Distribution, Ms. Hipp informed the HCF Receiver that her investment was actually split between an IRA and a non-retirement investment. After reviewing her records, the HCF Receiver reallocated Ms. Hipp's investment \$400,089.50 to Joyce Hipp (IRA) and \$299,756.20 to Joyce Hipp, individually. However, because the estate was notified after the Initial Distribution, her IRA account received \$21,117.96 that should have been paid to her. At Ms. Hipp's request, distributions otherwise due to her IRA will be paid to her individually until the overpayment to her IRA is eliminated. As a result, \$14,636.57 that would otherwise be distributed to the Joyce Hipp (IRA) will be paid to Joyce Hipp.

3. Mark Mathews (IRA).

The Mark Mathews (IRA) was reflected on the original Schedule of Claims as having a \$105,000 claim against Retirement Value. Accordingly, the Mark Mathews (IRA) received a distribution of \$7,151.36. Subsequent to the Initial Distribution, the Receiver was contacted by Mark A. Mathews regarding his IRA's \$45,000 claim against the estate. The Receiver researched Mark A. Mathews' assertions and concluded that there were two distinct Mark Mathews who invested in Retirement Value, each through an IRA. The Mark A Mathews (IRA)

invested \$45,000 and the Mark M Mathews (IRA) invested \$60,000. The 4th Amended and Restated Schedule of Claims reflects the correct division of accounts.


The Mark M. Mathews (IRA) received \$7,151.36 in the Initial Distribution and the Mark A. Mathews (IRA) received nothing. In other words, the Mark M. Mathews (IRA) received \$3,061.28 that should have been paid to the Mark A Mathews (IRA). To correct the overpayment to the Mark M. Mathews (IRA), the Receiver proposes to offset any future distributions to the Mark M. Mathews (IRA) until the overpayment is repaid. The Mark M. Mathews (IRA), therefore, will not receive a payment out of this distribution.²

The Receiver paid \$3,067.56 to the Mark A. Mathews (IRA) as its share of the Initial Distribution. There is a \$6.28 variance between the amount overpaid to the Mark M Mathews (IRA) and the amount paid to the Mark A Mathews (IRA). This slight overpayment results from the resolution of contested claims following the Initial Distribution. When the Receiver calculated the payment due to the Mark A Mathews (IRA), the Reserve for Contested Claims had been largely eliminated resulting in a slightly higher overall amount available for distribution and a correspondingly higher calculated distribution to the Mark A. Mathews (IRA). Because the overpayment is de minimus, the Receiver does not propose to correct it in this distribution.

ACCORDINGLY the Receiver requests (i) permission to make a distribution of \$3,000,000 to the Investors as set forth on the attached Amended Exhibit B and (ii) ratification of the \$3,067.56 distribution made to the Mark A Mathews (IRA) in furtherance of the Initial Distribution.
