

**HAMPTON TOWNSHIP
SALARY ORDINANCE
2017-01**

AN ORDINANCE FIXING THE COMPENSATION OF OFFICERS, OFFICIALS, AND CERTAIN EMPLOYEES OF THE TOWNSHIP OF HAMPTON, COUNTY OF SUSSEX AND STATE OF NEW JERSEY

BE IT ORDAINED by the Township Committee of the Township of Hampton as follows:

SECTION 1. The annual salaries of certain officers, the hourly salary of certain employees and the compensation to be paid certain other employees of the Township of Hampton shall be and are set each year by Resolution in accordance with the salary ranges herein set forth.

SECTION 5. This Ordinance shall take effect immediately after passage and publication as provided by law.
