Retirement Accounts: Use Edward Jones, Custodian

- Any long-term appreciated securities with unrealized gains (meaning they were purchased over a year
 ago, and have a current value greater than their original cost) may be donated to a public charity and a
 tax deduction taken for the *full fair market value of the securities* up to 30% of the donor's adjusted
 gross income.
- Since the securities are donated rather than sold, capital gains taxes from selling the securities no longer apply. The more appreciation the securities have, the greater the tax savings will be.
