# Essex Township - Minutes of the Regular Monthly Meeting

#### Visitor Statements:

#### County Commissioner Kam Washburn

- A committee has been formed to assess and track the processing of zoning violations.
- The State of Michigan has set new standards for indigent criminal defense services and the county is working on implementing these new guidelines.

#### Township Assessor Beth Botke

- Board of Review met on March 14<sup>th</sup> and 15<sup>th</sup>. There were 7 petitions (6 residential and 1 personal property).
- Ending balance: Ad Valorem: SEV \$107,636,100 / Taxable Value: \$58,370,130. DNR-PILT: SEV \$775,900 / Taxable Value \$401,026.

### Daryl Trefil and Mindy Thomas

- Presented fire fund budget report (2001-2017).

### Rex Ferguson

- Asked what road projects the road commission was going to work on this year.
- Supervisor Wardin stated they will resurface Colony Rd from Dewitt to Forest Hill and they will repair/replace guardrails on three bridges on that same route.

**Minutes of February 21, 2018 Meeting:** Wardin moved to approve the meeting minutes, with the word changing of "Maple Rapids Fire Department" to "Clinton Area Ambulance" in the "Trustee Report"; supported by George. Motion passed and carried (MPC).

- The general ledger for the period 1/1/18 – 3/17/18 was reviewed including checks #5960-5984.

- The checking balance is \$177,414.24. Total income for the period 1/1/18 3/17/18 was \$108,823.30 while total expenses were \$14,971.80.
- Cemetery CD balance is \$8358.10. Tax checking balance is \$1100.00.
- Received a proposal from SK&T to conduct audit.
- Gavenda moved to accept the treasurer's report, supported by Winsor. MPC.

- Year to date budget was reviewed.
- George moved to accept the clerk's report, supported by Winsor. MPC.

# Supervisor's Report

- Report on the Clinton County Road Commission meeting was given
- 2018 road projects were discussed with approximately \$90,000.00 allocated to be spent by township. Essex will again cover chloride treatment of roads and brush spray.
- Wardin moved to gravel four roads (Kinley Forest Hill to Wacousta, Hyde Road Lowell to McNeil, Bauer Road – Stone to Moss, Grove Road – Kinley to Colony) and to chip seal two roads (Hyde Road – Maple Ave. to Forest Hill, French Road – Airport to McNeil), supported by Winsor. MPC.
- "Roads and Bridges Millage" ballot language sent to county.

## New Business:

- Meetings for 2018-2019 will be held on April 18, June 20, August 15, October 17, December 19, February 20, and March 20.
- Proposed budget for FY 2018-2019 was reviewed.
