Minutes

A motion was made by Trustee Azzi, seconded by Trustee Freelove, to approve the October 19, 2016 meeting minutes with the addition of "not the installation cost" under "Old Business" during the discussion of the water rules and regulations. The motion carried 4-0.

Reports

The Board reviewed the Code Enforcement Officers report. It was noted that NYS law has returned to allowing one vehicle per property.

New Business

A motion was made to approve the 2016 unpaid Village Taxes to be returned to Steuben County for levy onto the 2017 Town and County taxes. The motion carried 4-0.

Board Concerns

Trustee Azzi feels the Village needs to revisit the amount of rent the Town pays for the Ambulance if the ambulance is going to stay another two to three years.
