THE UNRECABLES' 2022-23 SNOW SEASON VICTOR CHAN



s the new Trip Director for the 22-23 season, Mother Nature sure wanted to ex-

tend my duties as I write this on Saturday evening, June 3 after the dinner party in Sunshine Village in Mammoth.

The year started off a bit slow, with no snow in October. This made us decide to cancel the mid November trip. Of course, soon after that decision the snow started falling. As it turns out, there would have been enough snow as Mammoth received 61" for the month. At least for the mid December trip there was plenty. At the main lodge there was maybe 3-4 feet on top of one of the service buildings near chair 1. And though December snowfall total was 116", it paled in comparison to what was to come.

Just before our January trip Mammoth received a good amount of snow, adding to the 220" (over 18 feet!) that would fall in January. The tree branches in some areas were still covered in snow - quite a sight that I never tire of. The stairwell at the main lodge where we usually take our group picture has large windows where a large wreath is hung. The snow against the

window covered about half the window - about 6-9 feet up from the sill ledge.

In town, snow that was plowed from the streets piled up about 10 feet tall. Highway 395 heading down towards Bishop still had 3-4 feet piled up along the edge of the pavement.

February's trip was one for the books though. Those of us who went up Thursday lucked out. Roads were clear Thursday but that night the storm rolled in and snow fell for most of the night and Friday. In some areas in town a couple of feet accumulated.

When I got back to my car after skiing for the day, about a foot of snow was on it. Luckily I borrowed a snow shovel from the condo and was able to dig out a path to get to the road. Snow outside the Sunshine condos was piled up about 10-15 feet. The downstairs windows were covered with plywood so the snow that was packed on it would not cause damage. It made for very little if any natural light into the unit. The path going to the jacuzzi was like a snow channel with walls about 10 feet tall. Ski conditions were challenging as the dump continued and visibility was low. We found some untracked snow, some of it came up to our waist. It was pretty epic. Unfortunately the US Hwy 395 closed and most of our students couldn't make it up for the weekend. February saw "only 113".

In March the results of all the snow were on display. The big trail map sign that is outside of McCoy Station was buried almost to the top. At Tusk's outdoor patio on the third floor of the main lodge, we needed to walk up a snow ramp about 8 feet to get to the snow level where the ski and snow-board racks were.

Higher up the mountain, areas where there normally would be tree skiing and large boulders were just complete blankets of snow. The rock ridge under chair 23 between Wipeout and Dropout chutes was almost entirely covered in snow and one could ski from one chute to the other in several places. Avalanche chutes off of chair 22 which are normally somewhat narrow were probably 2 to 3 times wider. An "L" needed to be cut into the snowbank for Broadway Chairlift near the top so the chairs and riders could clear the snow. Large chunks of packed snow were scattered below that area. plowing was done to dig out chair 12. I skied past some big chunks of snow that had broken off the cornice near

there. They are not something you want to hit while skiing, as I saw someone do on a trail and proceed to lose a ski while going pretty fast. While riding up many of the chairlifts, I saw areas roped off directly under the chairs because the snow level was so high that people skiing could hit people riding up the chairlift. The now infamous "atmospheric river" dumped another 16 feet of snow at main lodge in March. In April, the snow level was still very high, both on the mountain and next to the Sunshine condos.

A little snow during the week before the May trip was a pleasant surprise, and the weather cleared nicely for the weekend. Again, coverage was still excellent.

Even though April and May only saw 3" and 10" respectively, the snow coverage this first weekend of June was still pretty amazing. Runs off of Broadway, Stump Alley, and Discovery were still fully covered. More of the rock ridge under Chair 23 was visible, but the chutes still did not have rocks on the runs. The snow pile at the main lodge parking lot was still about 50 feet tall. At Sunshine Village, the pool and jacuzzi areas were finally clear of the giant piles of snow, though there still were some piles on the tennis court and outside the condos.

Marina Sallaway said that in the almost 20 years of trip planning that she did, there hadn't been a June trip, so this season was definitely one for the books. Steve Lefkowitz, as the Historian, asked me to write an article about this year's historic snowfall. What a (long) season, looking forward to next year! ◆

MAMMOTH MOUNTAIN BREAKS RECORDS STEVE LEFKOWITZ



his season has seen a recordbreaking, historic snowfall at Mammoth Mountain

(see what I did there, by saving historic, it gives me permission to write about it in the Historian's column). We just had a June trip. We usually have trips scheduled every month during the season from November through May. These trips go almost every month because sometimes we've had to cancel trips due to poor snow conditions (ie., no snow). This happens mostly to our November instructors only trip, only to have conditions improve because of a late dump. But by then it's too late to help us because the trip had already been canceled and it would be too hard to reconvene (condos have been canceled, people have made other plans, ride sharing is no longer available, etc.).

This season started out that way with our November weekend being canceled and then, just before the trip was scheduled to happen, a late snowfall. We didn't know it at the time, but it was just the start of something epic - it never seemed to stop snowing. That June trip I mentioned above, well we didn't have to wait for a last minute dump to schedule it as Mammoth man-

agement decided long ago that they got so much snow this year that they will be in operation at least through the end of July. We have never had a June ski weekend at Mammoth in the 43 years that I've been associated with The Unrecables. It was a welcome change from the recent trend of marginal conditions because of not enough snow.

Mammoth joined the 700 Club this year for the first time. At the time of this writing, they received 715 inches of snow at the main lodge and recorded just under 900" at the summit (the way this season has been going, there's still time for more).

Month by month snowfall amounts are listed on their web site since the season of 1969-70 (Mammoth-Mountain.com). An average season's snowfall amount is about 400 inches. Of course, it doesn't hurt that Mammoth has the highest base lodge in California at 8,909 ft. with the summit being 11,053 ft.

With fresh snow on the tree limbs and branches most of the year, a sight that never gets old, Mammoth Lakes truly presented a "Winter Wonderland" this past season. We should all be grateful that we have this treasure in our backyards (well, 300 miles away anyway). •

Move United Waiver & Release of Liability Agreement

Move United, and its affiliated Chapters ("Released Parties") are non-commercial, not for profit activity providers. The purpose of this Move United Waiver & Release of Liability Agreement is to exempt, waive, and relieve Released Parties from any and all liability for any harm, wrongful death, personal injury, property damage, claim or cause of action, including, but not limited to liability arising from the negligence of Released Parties. "Released Parties" include Move United, Disabled Sports USA Los Angeles – The Unrecables, and their affiliates, successors, predecessors, parents, subsidiaries, owners, representatives, administrators, directors, officers, agents, coaches, employees, contractors, assigns, and volunteers; other participants, sponsoring agencies, sponsors, and advertisers; and, if applicable, the owners, operators, and lessors of premises on which the activities or events take place.

In consideration of the undersigned Participant being allowed to participate in any way in Move United and/or Disabled Sports USA Los Angeles – The Unrecables related events and activities, the Undersigned ("Undersigned" means the Participant or the Participant's parent, legal guardian, or legal representative when the Participant is under the age of 18 or legally incapacitated) agrees and acknowledges as follows:

- 1. Risks of Activity. Participant will be taking part in activities that can be hazardous and involve the risk of physical injury and/or death. The activities are inherently dangerous and Undersigned fully realizes the dangers of participating in the activities. The dangers and risks of the activities include, but are not limited to the condition of the premises and equipment, and the acts, omissions, representations, carelessness, and negligence of the Released Parties. Recognizing the risks and dangers, the Undersigned voluntarily chooses for Participant to participate in the activities and expressly assumes all risks and dangers of the participation in the activity, whether or not described above, known or unknown, inherent, or otherwise.
- Risks of Participation. The Undersigned recognizes and understands that while Released Parties have undertaken reasonable steps to lessen the risk of transmission of communicable diseases, including but not limited to, COVID-19, in connection with participation in the activities, the Released Parties are not responsible in any manner for any risks related to communicable diseases in connection with Participant's participation in the activities. Specifically, the Undersigned understands that COVID-19 is a highly contagious and dangerous disease, and that contact with the virus that causes COVID-19 may result in significant personal injury or death. Undersigned is fully aware that participation in the activities carries with it certain inherent risks related to transmission of communicable diseases ("Inherent Risks") that cannot be eliminated regardless of the care taken to avoid such risks. Inherent Risks may include, but are not limited to, (1) the risk of coming into close contact with individuals or objects that may be carrying a communicable disease; (2) the risk of transmitting or contracting a communicable disease, directly or indirectly, to or from other individuals; and (3) injuries and complications ranging in severity from minor to catastrophic, including death, resulting directly or indirectly from communicable diseases or the treatment thereof. Further, the Undersigned understands that the risks of all communicable diseases are not fully understood, and that contact with, or transmission of, a communicable disease may result in risks to the Participant including but not limited to loss, personal injury, sickness, death, damage, and expense, the exact nature of which are not currently ascertainable, and all of which are to be considered Inherent Risks.

- The Undersigned hereby voluntarily accepts and assumes all risk of loss, personal injury, sickness, death, damage, and expense for the Participant arising from such Inherent Risks. Furthermore, the Undersigned represents and warrants that Participant does not knowingly carry any communicable diseases that may be transmitted during participation in the activities.
- 3. Release and Indemnification. Undersigned unconditionally releases, forever discharges, and agrees not to sue the Released Parties for any claims or causes of action for any liability or loss of any nature, including personal injury, death, and property damage, arising out of or relating to Participant's participation in any Move United/Disabled Sports USA Los Angeles - The Unrecables events or activities or the Participant's presence on or travel to the premises where such events or activities take place, including, but not limited to claims of negligence, breach of warranty, and/or breach of contract the Undersigned may or will have against the Released Parties; and (b) agrees to indemnify, defend, and hold harmless the Released Parties from and against any liability or damage of any kind and from any suits, claims, or demands, including legal fees and expenses whether or not in litigation, arising out of, or related to, Participant's participation in such events or activities or the Participant's presence on or travel to the premises where such events or activities take place.
- 4. Helmet Use. Undersigned agrees that Participant shall use a helmet when participating in the following activities: Alpine skiing, cycling, equestrian, ice hockey, outdoor rock climbing, snowboarding, white water kayaking, white water river rafting, and any other activity when directed by Released Parties. Undersigned understands that a helmet is in no way a guarantee of safety and that no helmet can protect the wearer against all foreseeable impacts to the head, and that the activities can expose the Participant to forces that exceed the limits of protection provided by a helmet. Undersigned agrees to assume full responsibility for complying with this paragraph and that Released Parties shall not be liable for any injury or damages resulting from Participant's failure to use a helmet.
