

SUSPENDED PERSONS When a member or non-member has been suspended from IBHA, such suspended person is denied all privileges of IBHA and its charter associations. Suspended persons are ineligible to participate in any activity approved or recognized by IBHA. Suspended persons are ineligible to register any horse with IBHA. Any horse whose current registration shows it to be owned solely or in any part by a suspended person is automatically barred from participating in any recognized IBHA show or activity. Signatures of suspended persons will be honored only on legitimate transfer of ownership to persons not related to the suspended party.
