Attendance

Minutes of meeting held September 25, 1978, were read and corrected as follows: Jim Wiseman in attendance for Special District Approval not Grand County Water Conservancy District.

Minute

Schumaker reported that well was being drilled in Section 7. T26S, R22E. SLBM Schumaker further stated that samples had been sent to the Division of Health in Salt Lake City and that the well was producing from 800 to 1000 gallons per minute. After discussion of well and the naming of well, Bob Norman moved the well be named "BETTY #1" in honor of Betty Schumaker's successful efforts in locating well. D.L. Taylor seconded. MOTION CARRIED. It was further stated that the costs of drilling the well would be around \$15,000.00.

Progress of Well - Betty # T

Discussion was held as to the type of pump to be used in pumping the well also as to the possibility of using a City pump for pumping the well. After discussion, Sam Taylor moved the board be authorized to buy a satisfactory pump best suited for the well. D.L. Taylor seconded. MOTION CARRIED.

Approval Purchase of Pump.

Further discussion was held as to the Conservancy District and Special Service District build a suitable building to house the pump. After discussion, Curt Young moved the board approve a suitable construction for the pump. D.L. Taylor seconded. MOTION CARRIED.

Approval Facility to House Pump.

Ken McDougald informed the board that Harry Snow, attorney for George White was in the process of preparing necessary papers for boards approval for a trade from George White's well for culinary purposes for the city. McDougald further stated that the agreement was to call for an exchange of 1200 gallons of water with the Conservancy District paying pumping charge and equipment necessary for White Irrigation. Contract to be presented to the board for approval.

McDougald further informed the boards that the State Land Board would be in Moab Tuesday for a tour of the reservoir site and also that the business meeting would be at the Episcopal Church at 9:00 a.m. Wednesday. McDougald further requested the boards attendance and support of requests for r.o.w. and exchange of land with the BLM for leasing or purchase from the Conservancy District for the reservoir.

Discussion was held as to the employment of a Secretary for the District. After discussion, it was agreed on by members of both boards that the starting salary should be somewhere in the range of \$600.00 to \$700.00 per month.

Discussion was also held as to the renewal of the Position Bond now insuring E.L. Schumaker and Betty Bowen. After discussion it was agreed that Bretzke should inquire bond status with David Allen Insurance.

Position Bond Renewal

Schumaker stated he would like to tender his resignation as of October 15th. Discussion was held as to appointment of Schumaker to the Grand County Water Conservancy District. Discussion was also held as of 10/15/7 as to employment of Betty Bowen as assistant - secretary of the board. It was agreed that Betty would remain secretary until position was filled.
