4. <u>The Fundamentals of Marksmanship</u>: Proper grip, stance, trigger control, and other essentials to achieving accuracy. Live-Fire on the range: Private coaching with your instructor while you fire your handgun, using the skills and techniques you learned from the discussion portion.
