1. HOUSING PROGRAM DISCUSSION

Doc: Introduces Dan Kornelis to the council & staff.

Dan: Thank you for allowing me a few minutes to address the council.

I have been admiring your park and must say I just love it. It is beautiful. Let me start with a little of our history. We started in 1998 with 160 homes that were without plumbing. The fun part of my job is seeing the results and how lives are improved. When we ran out of money we transitioned to smaller rehab projects.

This is a partial list of jobs completed in the Walkertown area, mostly to the elderly.

There are 6 households currently on our waiting list, within the Walkertown tax jurisdiction, waiting to be served.

There is a \$750K ceiling on rehabilitation project grants.

Some homes are so bad they must be torn down and replaced with very small homes in the \$50 - \$60K range.

Doc: Some of your projects didn't end up all that small.

Dan: We try to use our funds where they are needed most.

Doc: We would prefer you contact the town first. Get Scott's input.

Dan: Next time we have a project in the Walkertown area we will talk with you first.

We also assist with first time home buyers with their down payment up to \$25,000. They must pay back the loan, attend finance classes, turn in a monthly budget including a plan for saving. They also get a personal success coach that they must meet in person once a month and a once a month phone call.

The journey is as important as buying the home.

Peggy: What is the income threshold?

Dan: Poverty for one person is 80% of \$35K.

Doc: Your move toward home replacement in the \$50K - \$60K worries us. Dan: The new homes are much more efficient. Owners save on electricity.

Scott: We have 4 condemned properties being torn down by the town. It would be a good time to tear down the 3 houses on Sullivantown.

Doc: The Waggoner house is the worst shape. Peggy: Get prices for demolition of all three.

Doc: We could try and give away. Randy: When are they starting?

Scott: August.

Randy: I'd like to see all three torn down and grass planted by fall.

Council is in agreement to get prices to tear down all 3 houses.

4. FIRE LANE PARKING ORDINANCE DISCUSSION

Scott: We get numerous complaints on Fire Lane violators in the shopping centers. I've included a Fire Lane Ordinance from Concord in your agenda.

As it is now, all criminal fines go to schools. If we made Fire Lane violations a civil fine, the fine would come to the town.

Doc: We have posted Fire Lanes with signs. Scott: The Ordinance would apply town wide.
