Perfluorooctanoic Acid (PFOA) and Perfluorooctane Sulfonate (PFOS) are chemical substances that have been used for decades to manufacture firefighting foam and many common household and consumer products, including non-stick cookware, fast food packaging, adhesives, paints, shampoo and cosmetics.

For years, states and water providers have followed the Environmental Protection Agency health advisory limit of 70 parts per trillion (ppt) for PFOA and PFOS in drinking water. In March 2023, the Environmental Protection Agency proposed to establish legally enforceable levels for six PFAS to protect the public health. EPA has proposed an MCL of 4.0 ppt for both PFOA and PFOS as well as a combined Hazard Index value of 1.0 for PFBA, PFHxS, PFBS, and GenX Chemicals. The final ruling is expected to be completed by December 2023.

This workshop will feature presentations from EPA leaders on PFAS Treatment and Funding. Each presentation will be followed by a Question and Answer session to allow for open and honest communication of the topic.


