Request Assignment to the Career Academy of Construction and Transportation

Application forms shall be available to all 8th-grade students at 8th-grade preview or at the MUSD District Office, Department of College and Career Readiness.

A student who wishes to attend the Career Academy of Construction & Transportation (located at **Madera High School**) must meet the following criteria:

- a. Students must identify an acceptable career goal associated with the Career Academy of Construction and Transportation.
- b. Qualifying specialized pathway courses include classes in Construction, Automotive Repair, and Heavy Truck Repair.
- c. Students must enroll in at least one qualifying pathway course associated with the Career Academy of Construction and Transportation during the entire school year (both semesters).
- d. Students must participate in SkillsUSA the Career Technical Student Organization CTSO) associated with the career pathways in the Career Academy of Construction and Transportation.

Career Academy transfers may be revoked at any time for the following:

- a. The student does not maintain enrollment during both semesters in at least one pathway course associated with the Career Academy of Construction and Transportation.
- b. The student is not associated with SKILLS USA the designated CTSO associated with the Career Academy of Construction and Transportation.
- c. The student fails to maintain acceptable academic progress, that is, his/her grade point average falls below a 2.0 for the overall academic year (two semesters). The student must attend MUSD summer school to have additional grades count in the overall GPA for that academic year.
- d. The student is designated as a habitual truant.
- e. The student commits an act in violation of the District's and/or school's policies, rules and/or regulations, the Student Handbook, or any other state and/or federal law.

Any student who has their Career Academy transfer status revoked will have the following conditions:

- a. The student must attend their school of original residency.
- b. The student will not be eligible to request a Career Academy application status at any time in the future.
- c. The student will fall under CIF athletic eligibility regulations and can be ineligible for Varsity competition for 365 days.

Applicants must complete all portions of the application, *provide current proof of residency when submitting the application, and have the application form signed.* Any information that is false or fraudulent with the intent to misrepresent the facts will void the application.
