I. PURPOSE

The purpose of this policy is to establish a process for recording and reporting student achievement and informing students and their parents or guardians of student progress toward achievement of the Graduation Standards and of the learning opportunities available to meet the needs and interests of students.

II. GENERAL STATEMENT OF POLICY

NWSISD will work with its member school districts to periodically advise students participating in NWSISD programs or activities, their parents or guardians, or both if appropriate, of the student's progress and achievement and of the choices and opportunities available for achieving learning, graduation, and the student's postsecondary educational and career goals.

III. RECORD KEEPING

NWSISD member school districts shall be responsible for keeping all educational records for their students participating in NWSISD programs or activities. NWSISD staff shall forward all student data, including progress towards or completion of the high school content standards, on participating students to the student's home school district.
