

## THIS DATE IN HISTORY

- Feb 2, 1962** The first U.S. Air Force plane is lost in South Vietnam. The C-123 aircraft crashes while spraying defoliant on a Viet Cong ambush site as part of Operation Ranch Hand.
- Feb 1, 1965** A Cuban publication reports that Cubans are helping to train the Viet Cong.
- Feb 7, 1965** As part of the already planned Operation Flaming Dart, 49 U.S. Navy jets from the carriers Coral Sea and Hancock drop bombs on barracks and staging areas at Dong Hoi, a guerrilla training camp 40 miles north of the 17th parallel in North Vietnam in retaliation for VC attacks on Pleiku.
- Feb 10, 1966** The U.S. 1st Infantry Division and a battalion from the Royal Australian Regiment conduct Operation Rolling Stone to provide security for road building crews on highways in Binh Duong Province, III Corps.
- Feb 11, 67-Jan 21, 68** The U.S. 1st Cavalry Division, assisted by elements of the 25th Infantry Division, the 22nd ARVN Division, and the ROK Capital Division conduct Operation Pershing in Quang Ngai and Binh Dinh Provinces, I and II Corps.
- Feb 27-May 8, 69** U.S. Marines conduct Operation Purple Martin in Quang Tri Province, I Corps. This is aimed at driving North Vietnamese troops back across the DMZ.
- Feb 1, 1970** Operation Good Luck is initiated by the U.S. Air Force to strike North Vietnamese and Pathet Lao forces in the Plain of Jars.

### **Court rules VA must pay disability benefits to ‘blue water’ Vietnam veterans**

A federal court ruled Tuesday that the Department of Veterans Affairs cannot deny disability benefits to thousands of Vietnam veterans who claim exposure to cancer-causing chemical defoliants simply because those vets served in the waters off the country’s coastline, and not inland.

The ruling marks a major victory for so-called “blue water” Navy veterans who have fought the department for years over the denials. VA officials have said the existing scientific evidence doesn’t justify the presumption of toxic exposure for the group and have strongly opposed legislative efforts to overturn their decision.

So while a veteran who served on the shoreline could receive disability payouts after contracting Parkinson’s Disease or prostate cancer, another vet who served on a ship a few miles away would have to provide evidence of direct contact with hazardous chemicals. Advocates have said that, given the time that has passed since the war, obtaining such proof is impossible and unfair. In their ruling, the federal judges agreed.

“These statutes cast no doubt on our conclusion that, by using the formal term ‘Republic of Vietnam,’ Congress unambiguously referred, consistent with uniform international law, to both its landmass and its 12-nautical-mile territorial sea,” the ruling states.

If VA officials opt not to appeal the decision to the Supreme Court in the next 90 days — or if the court decides not to hear the case — the result means that up to 90,000 blue water veterans could see disability payouts as early as this year.

If the court order stands, VA will be forced to cover the costs regardless of whether an offset is agreed upon, a potential drain on the department’s annual budget. Several new bills on the issue are already pending before Congress, and the chairmen of both the House and Senate Veterans’ Affairs Committees have promised to deal with the topic quickly this year. In a statement, Senate chairman Johnny Isakson, R-Ga., said that he was pleased with the court decision and would work closely with VA on the next steps.
