There being a quorum, Mayor Penrod called the meeting of the Vienna City Council to order at 6:30 p.m.

#### **NEW BUSINESS**

Alderman Racey made a motion to Authorize and Approve the Omnibus Consent Agenda consisting of the September 15, 2021 council meeting minutes and the Warrant (\$47,368.21). Alderman Hill seconded the motion. All in favor motion carried.

Alderman Pitts made a motion to Authorize and Approve funds for repair of public works pumper truck in the amount of \$3,074.58 (General Funds). Alderman Owen seconded the motion. All in favor, motion carried.

Alderman Moore made a motion to Authorize and Approve quote for preliminary water tank inspection and washout by Mid-South Tank Consultants in the amount of \$4,400.00 (Water Funds). Alderman Tuey seconded the motion. All in favor, motion carried. Penrod noted the tank inspection was scheduled for October 27<sup>th</sup>. City residents would be notified of a boil order.

Discussion was had between council and mayor concerning repair of the roof to the old city hall building on Locust Street opposed to purchasing a new building for storage mentioned by Alderman Hill. Alderman Racey made a motion to Authorize and Approve TIF Funds for the following: Replacement of roof Trico-Roofing- \$8,500.00, SI overhead garage doors-\$1,998.00. Alderman Owen seconded the motion. All in favor, motion carried.

Council briefly discussed the removal and replacement of city hall flooring. Council was in agreement to obtain bids on material and installation.

Alderman Moore made a motion to Authorize and Approve donation of \$500.00 (Community Funds) towards the Christmas on the Square event. Alderman Tuey seconded the motion. All in favor, motion carried.

### **PUBLIC COMMENT - None**

### **ELECTED/APPOINTED OFFICIALS**

Alisa Sowers, Depot mention scheduling a ribbon cutting for the grand opening of the new driving range on 146 East, McGill's Mulligans. Sowers also discussed ordering water and fruit for the upcoming 50/100 run.

Supt Racey mentioned the need for an easement at the end of Illini Court to gain easier access to an existing lift station. Racey said property owner was in agreement for the city to make a lane for access. Racey said he would contact city engineer.

Alderman Moore thanked the city on behalf of the Johnson County Elks for use of the park for the Fall Heritage Festival that took place over the weekend.

Fire Chief, Williams, questioned if the city ordinances included a time limit on cleanup for fire damaged structures. Williams also announced the Fire Department would be open for trick or treaters on Halloween from 5:00-8:00 p.m.

Mayor Penrod thanked the Johnson County Elks including Alderman Moore and Hill for their work with putting together this year's Fall Heritage Festival and parade. Penrod also thanked Supt. Racey for responding to several calls over the weekend concerning the sewer pump at the new restroom facility as well as major cleanup at the public works department.

Penrod mentioned the upcoming citywide cleanup scheduled for Monday, October 18th.

Mayor Penrod said he was contacted by Shawnee Correctional Center on updating their strike contingency plan. Penrod also said he was contacted by Southern Five concerning the city library qualifying for American Rescue Plan funds for new computers and printers. Council was in agreement to use funds for the replacement of needed equipment.

Penrod said due to the ongoing vandalism that is taking place at the city park, restrooms the city would be locking the facilities as well as monitoring activity at the park.

As there was no further business to discuss Alderman Racey made a motion to adjourn the meeting. Alderman Owen seconded the motion. Motion carried.

Mayor Penrod declared the meeting adjourned at 7:07 p.m.
