## AMANA NEWS AND NOTES

### Headstone Found and Returned to High Amana

The headstone stolen from the High Amana cemetery was found on Saturday, November 5 by a fisherman who spotted it when on the Koszta boat ramp on the Iowa River off of F Avenue, west of Marengo.

Iowa County Sheriff Rob Rotter, whose department has kept the family and the Amana Church informed, reported to the Amana Bulletin Monday, that a fisherman found the marble headstone laying among the large rocks along the Iowa River shoreline. He contacted the Iowa County Sheriff's office and the headstone was transported and returned to its proper place by an Iowa County Deputy working with Kloster Funeral Home and the Amana Church administrator's office. The gravestone is damaged.

The headstone weighs about 250 pounds and is a white marble US veteran's headstone provided by the US government for the marking of an American veteran's grave. As such it is protected by law. As per federal law, "under 38 CFR 1.218(b) (5), the destruction, mutilation, defacement, injury, or removal of any monument, gravestone, or other structure within the limits of any national cemetery is prohibited, with an associated fine of \$500. Under 18 U.S.C. 1361, willful depredation of any property of the United States (i.e., a headstone or marker in a non-national cemetery) shall be punishable by a fine or imprisonment under title 18 of the United States Code." This law applies to headstones in private or public cemeteries and those in federal, military cemeteries.

"We are asking that if anyone has any information related to this case to please call the sheriff's office," Sheriff Rotter wrote in an email about the case.

If it had not been for my parents, uncle, and aunt, and some close friends I knew or felt that I had few or no options. God, however, had a better idea and brought Charlie into my life.

Here was a man who had lived only three miles north of me all my life, went to the same church and school as I and even shared some relatives yet, because of our age difference we knew nothing of each other.

We finally met one day in June and had our first date on July 1st. The second date was July 4th and from then on we knew that we were meant for each other. Within ten days we were engaged to marry and the wedding took place November 17, 1972 - fifty years ago this year.

Life has not been easy - job loss, four cancer surgeries, one heart attack, loss of dear friends, and so the list goes yet I look back and think how that Friday night when Charlie and I said our vows to one another how God had this perfect plan all worked out.

Karen Jenkins used to describe these moments as "a God thing." It just happens without any reason at all.

I suppose I should take life like that and stop trying to control or figure out the whys and wherefores and instead remember that I'm not in charge and perhaps will not always know the reasons, but I should be faithful and as hard as it is remember the ending of the prayer, "Thy will be done."
